Dear Mayor Wheeler, Chief of Police Marshman and District Attorney Underhill:

For many years, the Multnomah County Republican Party (MCRP) has participated, like many other civic organizations, in the Avenue of Roses Parade, one of the first events of the Rose Festival, which is scheduled for this Saturday, April 29th. Hundreds of our members are expected to attend.

The organizer of the Parade has received an e-mail threat, a copy of which is transmitted herewith. The author, purporting to represent a "riseup" group, warns that if the organizer refuses to cancel the MCRP's registration in the parade, "we will have two hundred or more people rush into the parade into the middle and drag and push those people out". He or she further warns that "[y]ou have seen how much power we have downtown and that the police cannot stop us from shutting down roads".

This is criminal conduct. The author is threatening, and has already taken overt acts toward organizing the crime of riot: "while participating with five or more other persons the person engages in tumultuous and violent conduct and thereby intentionally or recklessly creates a grave risk of causing public alarm." ORS 166.015. At the least, what is described is a criminal conspiracy to engage in the crime of disorderly conduct in the second degree: an intentional "[o]bstruct[ion of] vehicular or pedestrian traffic on a public way". (ORS 166.025(1)(d). Another, even more disturbing threat to stab parade participants to death is appearing on Facebook (copy also enclosed).

The MCRP has watched with concern the rising lawlessness in the City of Portland, which has now metastasized to the point where potentially violent criminals are bragging that the police are powerless to stop them. The City is not powerless, and can easily identify "thegiver@riseup.net" and the other members of this criminal conspiracy, and more importantly, take steps to prevent their proposed criminal conduct.

One in five Portlanders is a member of the Republican Party, and differences of opinion we may have concerning appropriate levels of immigration and other political issues do not begin to constitute hateful rhetoric, much less offer any excuse for discarding American traditions of political participation and First Amendment protections in these circumstances.

The MCRP stands ready to work closely with the Portland Police to make this a safe event for the East Portland community and the many children and seniors who will be attending the event, but we will not grant a heckler's veto to these criminals. We ask that the Portland Police contact the event organizers and reassure them that the City has not determined to make Portland a sanctuary city for criminal rioters.

If you choose option 1 then we will have two hundred or more people rush into the parade into the middle and drag and push those people out as we will not give one inch to groups who

espouse hatred toward lgbt, immigrants, people of color or others. In case the message was not clear to you this is a sanctuary city and state and we will not allow these people to spread their views in East Portland.

You have seen how much power we have downtown and that the police cannot stop us from shutting down roads so please consider your decision wisely. Let us know your decision by tuesday by emailing back. We will also wheatpaste fliers across the march route naming sponsors and holding them accountable for backing an event with this type of rhetoric which may endanger future parades ability to get sponsors. We will also begin emailing groups who are participating in the march to inform them you are allowing a group of bigots to march in the parade.
