# Membership Application Form

## NCC Membership Categories and Entitlements

## Membership

NCC membership is open to any society, body or association (hereafter referred to as a group) that is interested in or deals with the conservation of nature and natural resources and subscribes to the Council's aims and objects and agrees to be bound by the NCC Constitution. For more information on NCC's aims and objects, visit the NCC website at: [www.nature.org.au](http://www.nature.org.au).

Membership must be renewed annually with membership falling due on the 1<sup>st</sup> of July each year. Any organisation that fails to renew their membership with 3 months of this date shall cease to be an NCC member. The NCC Executive Committee may revise membership fees from time to time.

All membership applications will be considered by the NCC Executive Committee and applicants will be notified once a decision has been made on their application.

### New Members only:

Full annual membership fees are payable for any new members approved by NCC's Executive Committee before 31<sup>st</sup> December in the year a new member is approved. The fees payable will be halved when the approval is between 1<sup>st</sup> January and 30<sup>th</sup> June in the year a new member is approved.

<b>Full Member</b>	To be eligible to be a Full Member, groups must have conservation as their primary objective.		
	A Full Member Body shall be entitled to send one delegate to Conferences if it has fewer than 100 members, two delegates if it has between 100 and 500 members, and three delegates if it has more than 500 members.		
	Full Member fees (GST Inclusive) are based on the number of group members:		
	<b>Category</b>	<b>Number of members</b>	<b>NCC Membership Fees*</b>
	<b>Small</b>	0-99	\$90
<b>Medium</b>	100-299	\$200	
<b>Large</b>	300-499	\$500	
<b>Extra Large</b>	500 & over	\$650	
<b>Associate Member</b>	Any group that does not wish to be a Full Member or that does not have conservation as its primary objective but supports NCC's aims and objects may apply to become an Associate Member.		
	An Associate Member may be represented at the NCC Annual Conference by one delegate.		
	<b>Associate Member fees* are a flat rate of \$165 (GST Inclusive) per annum.</b>
