**TREE QUANTITY AND SPECIES:**

(9) River Red Gum (*Eucalyptus camaldulensis*) at 6031, 6415, 6609, 7001, 8107, 9107, 10423, 6808, 6620 South Main Street, (1) Indian Laurel Fig (*Ficus microcarpa*) and (1) Rubber tree (*Hevea brasiliensis*) at 4328 South Main Street.

**REASON FOR REQUEST:** Sidewalk Repair (Measure M - Complete Streets)

**CEQA:** The tree removal(s) is/are (1) classified as operation, repair, maintenance or minor alteration of existing street, sidewalk, and gutter, involving negligible or no expansion of use beyond that previously existing; and does not involve the removal of a scenic resource; (2) the action is exempt under Article III, Section 1, Class 1, Category 3 (existing facilities - sidewalk repair or maintenance) of the City of Los Angeles Environmental Quality Act Guidelines (2002); and (3) none of the exceptions to the use of a categorical exemption as set forth in Section 15300.2 of the State CEQA Guidelines apply.

**TREE REPLACEMENT REQUIREMENTS:**

**PLANTING QUANTITY AND SPECIES:** (22), twenty-four-inch box size trees to be replanted on the 3900 through 11300 block of South Main Street: (10) Weeping Bottle Brush (*Callistemon viminalis*); (4) Desert Willow (*Chilopsis linearis*); (4) Cape Chestnut (*Calodendrum capense*); (4) Purple Orchid (*Bauhinia purpurea*).
