D **ANITA EARLS** – 58, civil rights attorney. No judicial experience. Endorsed by *George Soros, Eric Holder, Equality NC PAC.*

R **CHRIS ANGLIN** – 32, personal injury attorney. **Changed party affiliation** from *D* to *R* just before filing to run for Justice. *Criminal Record: DWI & Trespassing in 2009.*
