<p><b>a</b> <u>Wilderness Stewardship Program: In 2007, Friends of Nevada Wilderness staff and volunteers in partnership with federal land management agencies accomplished 35 restoration and monitoring projects around Nevada within wilderness areas. This work was accomplished by 249 volunteers who donated a total of 6,048 hours valued at \$85,193 of in-kind labor. Projects included building barriers/fences to prevent illegal OHV use in wilderness; wildlife habitat improvement projects; removing old fence, tanks, trash; monitoring recreation use; removing noxious weeds; photographing damage; trail maintenance; route restoration, etc.</u></p> <p>(Grants and allocations \$ _____ ) If this amount includes foreign grants, check here ► <input type="checkbox"/></p>	<b>115,800</b>
<p><b>b</b> <u>Wilderness Outreach and Education Program: In 2007 we produced our quarterly newsletter highlighting special places, upcoming events, how to volunteer, and kids in the wilderness. We produced the popular 2008 Wild Nevada Calendar showcasing Nevada's beautiful wild landscapes. We participated in numerous community events and gave 25 presentations to a broad range of Nevadans on the importance of wilderness and how to get involved. We held two volunteer appreciation events (Reno and Las Vegas). <p><b>c</b> <u>Save Nevada's Wild Forests Campaign: The campaign's goal is to protect and conserve the remaining potential wilderness lands in Nevada managed by the Humboldt-Toiyabe National Forest Service. To accomplish this, we have given educational programs, led tours, and talked with hundreds and hundreds of Nevadans about the importance of these wild lands for wildlife, recreation, watersheds, etc. We encourage public involvement with the Forest planning process and with contacting key decision makers.
