VOLUNTEER WILDERNESS STEWARDSHIP PROGRAM: IN PARTNERSHIP WITH THE AGENCIES, OUR VOLUNTEER STEWARDS CLEAN UP, MONITOR AND HEAL WILDLANDS AND IMPROVE WILDLIFE HABITAT AND RECREATIONAL TRAIL ACCESS. IN 2013, 851 VOLUNTEERS COMPLETED 85 RESTORATION PROJECTS GIVING A TOTAL OF 8,576 VOLUNTEER HOURS OF SERVICE HELPING RESTORE NEVADA'S WILDLANDS. THEIR TOTAL IN-KIND DONATION SUPPORTING THESE WILDLANDS WAS OVER \$232,000. WILDERNESS LEGISLATION AND PLANNING PROGRAM: IN 2013 WE BEGAN WORK ON THE SAGE-GROUSE WILDERNESS CAMPAIGN ASSESSING WHERE POTENTIAL WILDERNESS OVERLAPPED WITH SAGE-GROUSE HABITAT. OUR OUTREACH FOCUSED ON STRONG BI-PARTISAN LEGISLATIVE SUPPORT FOR THE PINE FOREST RANGE WILDERNESS IN HUMBOLDT COUNTY AND THE WOVOKA WILDERNESS IN LYON COUNTY. WILDERNESS EDUCATION AND OUTREACH PROGRAM: IN 2013 WE REACHED INTO OUR COMMUNITIES AROUND THE STATE AND PARTICIPATED IN 66 EVENTS, SIGNING UP VOLUNTEERS AND DISCUSSING NEVADA'S WILDERNESS AND WHY IT IS IMPORTANT FOR WILDLIFE, FOR CLEAN AIR AND WATER, AND FOR FUTURE GENERATIONS. 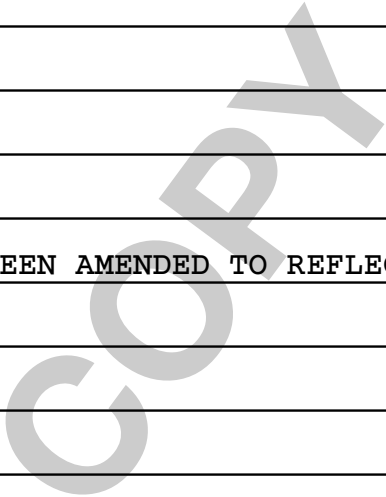
