VOLUNTEER WILDERNESS STEWARDSHIP PROGRAM: IN PARTNERSHIP WITH THE AGENCIES, OUR VOLUNTEER STEWARDS CLEAN UP, MONITOR AND HEAL WILDLANDS AND IMPROVE WILDLIFE HABITAT AND RECREATIONAL TRAIL ACCESS. IN 2014, 864 VOLUNTEERS COMPLETED 99 RESTORATION PROJECTS GIVING A TOTAL OF 7,640 VOLUNTEER HOURS OF SERVICE HELPING RESTORE NEVADA'S WILDLANDS. THEIR TOTAL IN-KIND DONATION SUPPORTING THESE WILDLANDS WAS OVER \$200,000.
