WILDERNESS STEWARDSHIP PROGRAM: IN PARTNERSHIP WITH THE AGENCIES, OUR VOLUNTEER STEWARDS CLEAN UP, MONITOR AND HEAL WILDLANDS AND IMPROVE WILDLIFE HABITAT AND RECREATIONAL TRAIL ACCESS. IN 2018 ABOUT 700 VOLUNTEERS COMPLETED 86 RESTORATION AND MONITORING PROJECTS GIVING BACK A TOTAL OF \$243,855 OF IN-KIND VOLUNTEER SERVICE.
