## IMMIGRATION SAATHE MALVAANU THAI TO SHOON KARVU

### IMMIGRATION TAMAARA GHARE AAYETO

**GHAR NU BAARNU KHOLVU NAHIN.** Kaaranke Immigration na officer tamaara gharma tapaash na order vagar aavi sake nahin.)

**TAPAASHNO ORDER GHARNA BAARNA NICHETHI PASS KARWA KAHON.** Ghar nu baarnu kholvun nahin. Immigration officer ne kaho ke tamari paasejo ghar tapaashno order hoy to baarana nichethi pass kare.

**TAPPASH ORDERNE BARAABAR CHECK KARO:** Baraabar check karo ke order par tammaru naam ane address chhe ane order jugde athwato magistrateni sahin walon chhe. Barrabar check karo ke order bijakoi na naamno tonathi keje tammara address par rahen chhe.

**JEKAIN THAY TENI NONDH KARVI.** Immigration agents na naam ane badge numbers puchhava ane lakhi leva. Dhaad vakhte jekain thai te badhu nondh karvun ane phota padva.

## **JO IMMIGRATION TAMNE RASTA PAR ATHAWATO PUBLIC JAGYAMA MALETO SHU KARVUN**

**PUCHO:** “Mane jawani parwangi chhe?” ane **BIJU KASU BOLSO NAHIN.** Immigration officers tamne kaaran vagar pakdine sawaal puchhi nahin sake. Tamaaru naam athwato biji koi tamari information aapta pehla hamesha puchhuvun ke mane jawani parwangi chhe. Ae loko jo tamne “haa” kahento tamaare tyanthi tarat jataan rehvan. Ae loko jo “Naa” kahento tammare aevun kahenvun ke tame koi sawwal na jawaab aapwa mangta nathi, ane tamme vakil saathe vaat karwa mango chho.

**TAPPAS KARWAANI PARWANGI AAPVI NAHIN.** Jo immigration officers tammari sampatini tappash karwaano prayant kare to tamaare kehvu ke “Hu tappash ni parwaangi aapti nathi”

**BHAAGVUN NAHIN.** Jo tamme bhagsoto immigration officers tamne kayada pramaane roki sakse.

## **YAAD RAAKHO**

**TAIYAAR RAHON....**jo tamne pakdwama aaveto shu karvu aemaate tamen ane tamaara family baraabar taiyar rehvan. Tamaara family members ane vakilna phone numbers yaad rakhwa. Tammara chhokra/chhokri ane tammari tabiyat maate na emergency plans karwa. Tamaara badhha jaruryati documents ni copies tammari saathe ane koi bija viswasu saathe raakhvi.

**KASHUN BOLVUN NAHIN.** Immigration officers na koi sawwalno jawwab athwato biji koi information aapvi nahin. Jo tame bolso athawato information aapsoto te tamari viruddhama vapri sakaase.

**JO TAMNE PAKDWAMA AAVETO TENO VIRODH KARVO NAHIN.** Immigration officer tamane kaarnvagar pakde topan teno virodh karvon nahin.

**JUTHTHU BOLVUN NAHIN ATHWATO BANAWATI DASTAWEJO BATAAWAWAA NAHIN.** Tame jo US citizen hov athwato kaayada pramaane US maa hovto aani sabiti/proof na papers bataawawaa. Jo tamari paase immigration ni sabitina papers nahi hoyto immigration officer ne kahon tamen kasu bolwaana nathi. Tamaara potaana desna koi papers bataawawaa nahin.

**MAARE VAKIL SAATHE VAAT KARWICHHE AVEVUN KAHON.** Vakil saathe vaat karya vagar kasu bolvun nahin ane koipan niryan levaa nahin.

**KOI PAPERS PAR SAHIN KARVI NAHIN.** Immigration officers tamne kadaach koi paers sahin karva kehse pan vakil saathe vaat karya vagar koi papers par sahin karvi nahin.

## **JO IMMIGRATION OFFICERS TAMNE MALWAA AAVE TO**

**KOI PAN PRASHNANA JAWAAB AAPWA NAHIN.** Karanake tamne kasu nahin bolwaano haq chhe ane tamne vakil saathe vaat karwaano adhikaar chhe.

Jo immigration officer tamaara ghare aaveto **TAMAARA GHARNU BAARNU KHOLVUN NAHIN.** Immigration officer passe jo warrant hoyto aemne kahoke tamaara ghar na baarna nichethi warrant aape. Warrant par judge athwato magistrate ni sahin chheke nahin te baraabar check karvun.

**AA CARD NE KAAPINE IMMIGRATION OFFICER NE AAPVUN.** GHARNU BAARNU KHOLVUN NAHIN kaarnke ae Americana bandhaaran pramane tamaaro adhikaar chhe.
