

Free Legal Clinic to Help DACA Students File Their Renewal Applications!

Friday, Sept. 22, 9:00 am to 3:00 pm, Atrium 111

If your DACA **expires between September 5, 2017 and March 5, 2018**, you must renew your application immediately. Applications for DACA renewal need to be **received (not postmarked) by the US Citizenship and Immigration Services by October 5, 2017**. DACA recipients whose DACA has already expired are no longer eligible to renew.

In order to renew, you must complete and sign the following documents, in addition to paying a renewal fee of \$495:

- Form I-821D, Consideration of Deferred Action for Childhood Arrivals
- Form I-765, Application for Employment Authorization
- Form I-765W Worksheet

If you fail to renew your DACA by October 5, you may lose whatever protection may be afforded DACA students under some future Congressional legislation.

To assist students with their DACA renewals, the WPU Committee to Support Undocumented Students and Workers will be holding a free clinic on the WPU campus. The clinic will be led by Jason Scott Camilo and Carolina Curbelo, attorneys in private practice specializing in immigration and nationality law (bilingual English/Spanish) who work with the Pro Bono Committee of the American Immigration Lawyers Association, which provides free legal services.

The clinic will be held **Friday, Sept. 22, from 9:00 a.m. to 3:00 p.m., in Atrium 111, on the main WPU campus, 300 Pompton Road, Wayne, NJ 07470**. Attorneys will be available to meet one-on-one with students **at no cost**. No appointment is necessary.

If possible, you need to bring the following with you:

- A copy of your last application form, if you have it.
- Your current DACA Work Card
- Your current and prior passports
- Your driver's license
- Your Social Security card
- 2 Passport Photographs

You will need to pay a \$495 application fee to the US Citizenship and Immigration Service. If you can bring a check or money order with you on Friday, you should do so. If you cannot, please still come to the clinic as there are various scholarship opportunities and you still have some time to get the money.
