
HOUSING AUTHORITY ROLES

- Administering tenant-based Housing Choice Vouchers (governed by state and federal law)
- Project basing vouchers (governed by state and federal law)
- Affordable housing development (governed by state law)




THE PROBLEM

REASONS FOR VOUCHER SEGREGATION

- Below market program rents.
- Lack of affordable units (partly due to history of segregation & exclusionary zoning)
- Federal program restrictions tied to how the state defines HA jurisdictions.
- Disincentives for housing authorities to promote mobility.

RULES ON HOUSING AUTHORITY JURISDICTION

Federal

HUD defines housing authority jurisdiction as "[t]he area in which the PHA [Public Housing Authority] has authority under *State and local law* to administer the program." (24 C.F.R. § 982.4(b))

State

Under state law, housing authority jurisdiction may only extend beyond municipal boundaries when:

[t]he governing bodies of two or more municipalities ... create a regional housing authority, which shall have all the powers, duties and responsibilities conferred upon housing authorities by this chapter and chapter 130. The area of operation of such authority shall include the municipalities for which such authority is created. (Conn. Gen. Stat. § 8-40).

WHAT DO RESTRICTIONS ON JURISDICTION MEAN FOR CHOICES FOR VOUCHER HOLDERS?

- Year 1 Housing Choice Voucher Program: Housing authorities typically restrict to jurisdiction to ensure access to full administrative fees.
- Year 2 and beyond: Housing authority loses portion of administrative fees if household leaves jurisdiction, so no incentive to promote integration and engage in mobility counseling.



WHAT DO LIMITATIONS ON HA JURISDICTION MEAN FOR OTHER ACTIVITIES?

- Project Based Vouchers Restricted to jurisdictions.
- Development Technically restricted to jurisdiction. Question about possibility of working with an affiliated development entity.


CHANGE THE STATE DEFINITION OF JURISDICTION

■ Add to 8-40: Any housing authority may opt to adopt extended authority including any high or very high opportunity census tract within the state of Connecticut, as defined by section 8-348, within 30 miles of its municipal borders.

■ To note:

- At housing authority's option.
- Expansion only to higher opportunity areas (designation already used by DOH), but more options than currently available.
- Maintains state's current housing authority structure.
- Extends by 30 miles.
- Additional changes needed to statutes to ensure there are not unintended consequences (eminent domain; police power)

BENEFITS


- Removal of some artificial barriers to housing choice.
- Increased Housing Choice Voucher utilization rates for housing authorities.
- Increased access for families with disabilities to a wider array of units that fit their needs.
- Support of housing integration.
- A greater ability for housing authorities to administer their programs unconstrained by geographic limitations that prevent them from affirmatively furthering fair housing.




