**AFFIDAVIT OF ATTEMPTED PERSONAL SERVICE**

I, SCOTT WHEELER, Process Server of West Coast Title Search Ltd., of #100 - 840 Howe Street, in the City of Vancouver, in the Province of British Columbia, MAKE OATH AND SAY THAT:

1. I am an employee of West Coast Title Search Ltd., and as such have personal knowledge of the matter and facts hereinafter deposed to, save and except where the same are stated to be upon information and belief, in which latter case I verily believe them to be true.

2. We were instructed by our client, the Law Offices of Pivot Legal Society, of 121 Heatley Avenue, Vancouver, British Columbia, to serve the above-mentioned GEORGE WOLSEY, at 21017 36 Avenue, Langley, British Columbia, with the Summons to a Payment Hearing, dated July 23, 2013, and Letter from Pivot Legal Society, dated August 1, 2013, in this action.

3. At 2:58 p.m., Thursday, August 8, 2013, I attended the given address, 21017 36 Avenue, Langley, British Columbia, and received no answer at the main door. At that time, I left my delivery card with a message requesting that GEORGE WOLSEY contact me at our office telephone number posted to the main door. I then spoke with an ADULT MALE in a trailer, located on the left side of the rear driveway, who confirmed that GEORGE WOLSEY lives in the main part of the house but informed me that he was not home. The ADULT MALE further then informed me that GEORGE WOLSEY was not home often.

4. At 10:22 a.m., Saturday, August 10, 2013, I attended the given address, 21017 36 Avenue, Langley, British Columbia, and noticed an ADULT MALE tying up a trailer in the driveway that was hooked to the back of a Dodge pick up truck with BC plate #5458 HX. As I approached the ADULT MALE, I noticed a Rottweiler dog in the back of the pick up truck. I then spoke with the ADULT MALE who informed me that GEORGE WOLSEY had gone fishing and would be away until September. At that time, I left my delivery card with a message requesting that GEORGE WOLSEY contact me at our office telephone number with the ADULT MALE to pass on to him.

5. At 12:45 p.m., Monday, August 12, 2013, I conducted a search through Google for GEORGE WOLSEY and found many articles relating to him and photographs of him. At that time, I noticed that the ADULT MALE I spoke with at the given address, 21017 36 Avenue, Langley, British Columbia, on Saturday, August 10, 2013, referred to in paragraph 4, was GEORGE WOLSEY as per the photographs I found of him online.

6. At 7:51 a.m., Tuesday, August 13, 2013, I attended the given address, 21017 36 Avenue, Langley, British Columbia, and received no answer at the main door. At that time, I noticed the same Rottweiler dog, referred to in paragraph 4, inside the house and that the upper windows were open. I then left my delivery card with a message requesting that GEORGE WOLSEY contact me at our office telephone number posted to the main door. I further then noticed the same Dodge pick up truck, referred to in paragraph 4, parked in the driveway along with a Ford F150 with BC plate #FD 5198 and a Volvo with BC plate #142 WXE.

7. At 9:24 a.m., Wednesday, August 14, 2013, I attended the given address, 21017 36 Avenue, Langley, British Columbia, and received no answer at the main door. At that time, I noticed the same Rottweiler dog, referred to in paragraph 4, inside the house. I then noticed the delivery card that I had previously left posted to the main door on Tuesday, August 13, 2013, was gone. I further then left another posted to the main door. I then noticed the same Dodge pick up truck, referred to in paragraph 4, and Ford F150, referred to in paragraph 6, parked in the driveway.

8. To the best of my knowledge, GEORGE WOLSEY has made no effort to contact our office in response to the messages that I have left for him, to date.

9. Based on the foregoing, I am of the opinion that GEORGE WOLSEY is evading service of the documents.
