Dear Speaker Silver:

We urge that the New York Health single-payer bill, A.5389-A, be brought to the Assembly floor for a vote this session.

The Affordable Care Act makes important repairs to our broken health care system. But even with those repairs, our system — based on insurance companies — has unavoidable problems. We constantly hear from our constituents:

- Many health plans have narrow restricted provider networks.
- Consumers must pay high deductibles, co-payments, and out-of-network charges — out-of-pocket spending that shifts a large part of the cost to the individual.
- Employers continue to shift more of the cost of coverage to their workers, or drop coverage entirely.
- The cost of coverage and care is billions higher than it needs to be because employers, consumers and taxpayers pay for the high administrative costs and profits of insurers, and hospitals, physicians and other health care providers spend more on dealing with insurance companies, billing and collecting.

Insurance companies and employer self-insured plans are still in charge. The system doesn't work for patients, health care providers, employers, individuals, and taxpayers. The **only way to truly fix it** is a universal, single-payer, publicly funded plan that replaces insurers, saves billions, and provides better coverage for all of us.

New York Health has been endorsed by the Working Families Party, Citizen Action, the New York State AFL-CIO, SEIU 1199, the New York State Nurses Association, Communications Workers of America, United Auto Workers 9 & 9A, the Doctors Council SEIU, the Committee of Interns and Residents SEIU, United University Professions, IATSE Local 1, the New York State Academy of Family Physicians, and the New York State American Academy of Pediatrics, along with 91 state legislators.

All New York residents would receive comprehensive health coverage under "New York Health." Publicly sponsored coverage would replace insurance company coverage, and premiums would be replaced by broad-based public financing based on ability to pay.

New York Health would eliminate the local share of funding for Medicaid. Eliminating the need for employers to provide health coverage would make New York dramatically more job-friendly, especially for small businesses, start-ups and low-margin businesses, while offering better and more secure coverage to every New Yorker.

New York can do better. ***We want to be able to vote for this solution.***
