## Issue Questions

1. Do you support ending the money-based bail system?

Yes                          No

Comments:

I support the Attorney General's position that judges should pick the least onerous option to ensure that criminal defendants appear in Court. I supported his position openly in the Legislature, and in my public comments. The effect of his policy statement has been significant, with Marylanders charged with non-violent offenses less likely to be held on bails they can not pay.

2. Will you support a \$15 per hour minimum wage for all Maryland workers? If yes, over what time period would you suggest implementing it? Do you support including an indexing provision?

I support an indexing provision. I believe the length of time in Delegate Hettleman's legislation is appropriate.

3. Do you support public financing of State Senate and Delegate races similar to systems enacted in Montgomery County and Howard County?

I'm generally inclined to support an expansion of public financing in elections. I'd like to learn more about the public financing systems in those counties, and see how those systems operate in this election cycle.

4. Do you support increased protections for workers in terms of scheduling practices? In particular, will you support requiring employers to give 3 weeks' notice to employees of their shift schedule, requiring employers who call employees into work only to send them home before the end of their shift to provide a certain percentage of the pay that the employee would have made that day, and prohibiting employers from scheduling an employee to work back-to-back shifts or shifts scheduled only a few hours apart without the employee's consent?

Comments: I would support increased protections for workers related to scheduling practices. I would like to learn more about how the specific proposal above would work in practice before I support or oppose it.

5. Do you support workers' rights to organize in the private and public sectors? Will you make it a priority that all public employees be covered by a public employees relations act, similar to the National Labor Relations Act, which has governed work in the private sector for over 80 years?

6. We believe that the financial security of women is integral to the health of our economy. Do you feel that legislation ensuring the equal treatment of men and women in the workplace is appropriate? If so, what legislation will you support as a member of the General Assembly to bring women to parity with their male colleagues?

Comments:

One example is legislation I am co-sponsoring this Session in the General Assembly would prohibit asking for a job applicant's prior salaries in a job interview. Asking for job salaries from previous jobs results in employers generally giving lower salaries for women because, historically, women have been paid less than men in equivalent positions. I also support anti-discrimination legislation and paid family leave.

I would be remiss if I didn't mention that studies have shown women around the country have benefited from Earned Sick Leave policies at a higher rate than men - and I am proud to have led the fight for that legislation for the last four years here in Maryland.

Comments:

I have received the support of NARAL in previous elections because I support the right of women to make decisions related to their reproductive health. I support abortion rights consistent with the rights established in the Maryland Constitution, and I support existing Maryland law related to access to abortions by younger Marylanders and low-income Marylanders.

However, there are circumstances where the State may place restrictions on a patient seeking an abortion. For example, I would not support abortion to select the gender of the child. I would also not support abortion to abort a child with a physical deformity, unless the deformity threatens the life and health of the mother. I recognize that these are not the examples to which you were referring, however, I wanted to answer the question as it was posed.

9. Will you support single-payer health care in Maryland? If so, how would you pass it and how would you pay for it?

Comments:

Maryland has an all-payer medical system, which has saved the State millions of dollars. I support single payer health care in principle as it would save even more money, but I do not have a plan to pay for it.

Comments: I support the existing charter schools that exist in my district. I do not support changes to the existing charter school law, and I particularly do not support changes to the requirements that teachers at charter schools must be part of the collective bargaining agreement in the school district where they are located. Charter schools should be held to the same standards and requirements of a public school, and I would oppose efforts that seek to change that.

12. Do you support or oppose school vouchers that would allow public school students, K-12, to attend a private school instead of their local public school? Please explain your support or opposition.

Comments: Vouchers take money away from public education. The current voucher system also supports some schools that discriminate against LGBT Marylanders.

13. Will you support making state colleges and universities free for all in-state students?

Comments: My instinct is to support free tuition for all in-state students, however, I'd like to consider this issue more. There are some people who argue that eliminating tuition for all students would benefit upper and middle class families without helping more qualified low-income students attend college. There are others that would argue that greater access to vocational and skills training, including more access to paid apprenticeships, would be more effective in raising opportunities for all Marylanders.

I also know one underlying reason for free in-state tuition is that too many Marylanders leave college with too much debt. I'd consider a state fund to help Marylanders consolidate student debt at lower interest rates, and other ways to lower the need for student loans for Maryland students.
