

Success in Harrisburg

On Dec. 22, 2011, Gov. Corbett signed S.B. 732 into law, which received final approval by the Pa. General Assembly on Dec. 14, 2011. This legislation requires abortion facilities to meet the same standards as other "Ambulatory Surgical Facilities," such as building access, emergency equipment and availability of trained medical personnel. The Pa. abortion industry claims that the enforcement of this legislation would result in the closure of approximately 17 of our state's 20 abortion chambers. This claim is highly optimistic, but, for certain, the enforcement of this legislation will significantly reduce the great harms committed by and the political protection received by Pa.'s abortion industry. The passage of this legislation also ends a lengthy dry spell as the Pa. General Assembly last passed pro-life abortion-related legislation in November 1989.

This legislation takes effect on June 22, 2012. Before then, the Pa. abortion industry is certain to file a court challenge against this legislation. Please write to Pa. Attorney General Linda Kelly at 15 Strawberry Square, Harrisburg, PA 17120 and urge her office to zealously defend this legislation from this court challenge. The Pa. House and the Pa. Senate passed this legislation, respectively, by votes of 151-44 and 32-18. Renewing Efforts to Protect Marriage

Our state pro-life movement will be renewing our efforts to pass a state constitutional amendment to define marriage as the union of one man and one woman. We expect a vote on this issue in early Spring 2012 in the State House Government Committee. This effort remains crucial to protecting the sanctity of human life and the family.

Opponents of marriage and advocates of normalizing homosexual behavior, from President Obama to members of the Pa. Legislature, do not rest. The Obama Administration is urging that the federal Defense of Marriage Act be declared unconstitutional and taking their normalization advocacy worldwide.

In Pa., the House and Senate have formed a new "Lesbian, Gay, Bisexual and Transgender" Caucus. The purpose of this is to normalize the homosexual lifestyle, which is morally, psychologically and physically harmful, and to pressure for the "marriage" of same gender people. Local legislators constitute the majority of the Caucus – Senators Leach (co-chair) and Farnese; Reps. B. Boyle, K. Boyle, Briggs, Brown, Bradford, Cohen, Curry, Davis, DeLussio, Gerber, Josephs, McGeehan, O'Brien, Payton, Roebuck, Santarsiero and Shapiro.

Brigham Jailed, But Still Operating in Pa.



On Dec. 29, 2011, a Cecil County, MD Grand Jury charged abortionist and abortion chamber chain operator, Steven Brigham, with five counts of first degree murder, resulting from his operation of a secret late-term abortion chamber. As a result, New Jersey authorities are holding him in Camden County Jail while he awaits extradition to Maryland. The Grand Jury also charged Brigham's fellow abortionist, Nicole Riley, with one count of first degree murder.

Despite Brigham's lengthy record of criminal activity and medical malpractice, Gov. Corbett's Dept. of Health (DOH) continues to allow Steven Brigham to operate abortion chambers in Pittsburgh and Allentown in violation of his March 2008 consent decree with the DOH. Brigham has avoided compliance by claiming that these abortion chambers are "owned by his mother." Please contact Gov.
