2021 - A SIGNIFICANT YEAR FOR LIFE

This year the Queensland government has promised an assisted suicide (euthanasia) Bill, and if that isn't bad enough palliative care resources in Queensland are desperately insufficient. We are fighting against assisted suicide and for better palliative care.

Queensland abortion rates have soared since the State Labor Government legalised abortion to birth in 2018, and sex-selective abortion is happening in Queensland since the law change. We are fighting for the unborn and doing all we can to draw attention to this tragedy, to bring about change.

On a federal level MP for Dawson George Christensen has drafted revolutionary legislation that, if passed, would mean babies born alive after an abortion are protected by law and given medical care. At the moment these poor little babies are left to die in Queensland, Victoria, the ACT, Tasmania, the NT and Western Australia. We are doing everything we can to make sure it comes to a vote this term of Parliament.

We also continue to regularly engage with politicians, the community, church groups and the media about abortion and euthanasia.

We are fighting on all fronts, and we're better together. Thanks for being an important part of the fight for life.
