



Dear Governor,

We, the undersigned members of the Renew America Movement, are writing to express our concern with the number of bills that are being introduced and passed across the country that impact the right to vote. Our coalition is composed of current and former Republican members of Congress, governors, state legislators, party leaders, cabinet secretaries, senior officials, and thought leaders. We encourage you to use your power as Governor to block any bills that would lead to voter disenfranchisement or suppression.

Attacks on voting rights are nothing new, but in the aftermath of a coordinated effort to lie about, and then overturn the 2020 election, we have seen an unprecedented number of voter suppression laws introduced at the state level.

The 2020 election gave people more ways to participate in our democracy. As a result we saw record voter turnout with no evidence of serious or substantial fraud. Instead of celebrating this, many states are now trying to make it harder for some people to vote under the guise of "election security". States should be making it easier for people to vote, not harder. As Governor, we ask that you stand on the side of increased voting and against the efforts to restrict democracy.

Additionally, with the release of the 2020 census, states will soon begin their redistricting process, opening the door to the longstanding problem of gerrymandering. Drawing districts based on political or racial lines is undemocratic and we stand firmly against the process, regardless of the party responsible. In your power as Governor, we urge you to speak out in favor of a fair redistricting process and to push back against gerrymandering.

Lastly, we are concerned with bills that are being introduced with language that would make it much easier to overturn an election, thereby defying the will of the people. Despite immense pressure to generate a different result, our institutions held in 2020. Some of the proposed changes to how elections are carried out and overseen could allow partisan actors to overturn future elections. These bills should not be allowed to become law as they would threaten the integrity of our elections.

We hope that you will use the power of your office to protect the right to vote and our democracy and work on a good-faith, bipartisan basis when making any changes to voting laws.
