Re: international and domestic travel costs

I refer to your email, which we received on 24 May 2016, requesting information about international and domestic travel costs. In particular, for the Auckland Council group, including the CCOs, you have requested:

- The total amount spent on international travel and disbursements, per financial year since 2014/15 and including the year to date 2015/2016; and
- The total amount spent on domestic travel and disbursements, per financial year since 2014/15, and including the year to date 2015/2016.

Auckland Council

The table below outlines Auckland Council's total spend on international and domestic travel, including flights, accommodation, car rental and disbursements. Council's travel bookings are arranged through a travel management company that ensures we get the best possible price on fares and accommodation by accessing 'government' rates.

Non-employee travel includes those contracted to provide services to RFA. RFA manages five separate businesses (Auckland Live, Auckland Conventions, Auckland Zoo, Auckland Stadiums and Auckland Art Gallery) all of which have an international focus and undertake significant commercial activity in order to deliver on RFA's Statement of Intent.

This activity includes negotiations with international promoters to bring events to Auckland, working with galleries and collections throughout the world to present large international exhibitions, and attending trade shows to showcase the iconic venues that we manage and secure conventions business. RFA funds third party travel when it contributes to business objectives and when part of a negotiated commercial agreement. Approximately 65% of RFA's funding is received from commercial sources and investment in attracting this revenue, including international travel, is essential to supporting RFA's commercial remit. RFA is also a key participant in international conservation programmes associated with species at Auckland Zoo.

Auckland Council Investments Limited (ACIL)

ACIL's total travel expenses from 01 July 2014 to 31 May 2016 were \$10,619. The table below provides the breakdown for domestic* and international expenses by financial year.

REQUEST FOR INFORMATION UNDER THE LOCAL GOVERNMENT OFFICAL INFORMATION AND MEETINGS ACT 1987

On 24 May 2016, Watercare received from the Auckland Council your request for information under the Local Government Official Information and Meetings Act 1987 (LGOIMA) for:

- 1. We request the total amount spent on international travel and disbursements, per financial year since 2014/15 and including the year to date 2015/2016.
- 2. We also request the total amount spent on domestic travel and disbursements, per financial year since 2014/15, and including the year to date 2015/2016.

Our Response:

- · International travel costs
 - o 2014/15 financial year \$76,565
 - o 2015/16 Financial year \$70,787 (10 months to April 2016)
- · Domestic travel costs
 - o 2014/15 financial year \$114,082
 - o 2015/16 Financial year \$96,178 (10 months to April 2016)

The travel costs include flights, accommodation, meals, rental cars, taxis and other costs directly related to travel outside Auckland.
