

Last week, we had our first in-person session! It felt like the first day of school getting to go to Concord and work with my colleagues for the first time in person. Here we are on the Senate floor:





With key legislative deadlines coming around the corner, we have plenty of work ahead of us. Here are some of the highlights:

Legislative Update

HB 177 Voted Down: Monday, I voted to reverse the ITL recommendation on HB 177, a bill that would help protect our state parks and the immense impact they have on our local economy and communities.

Depending on what happens at the floor vote on

Thursday, unfortunately, the bill is likely to be retained until next session. In the meantime, my colleagues and I will continue to advocate for the protection of our state's environment.

Housing Assistance Bill Passes Out of Committee: Great news out of the House Judiciary Committee—SB 126, the bill I'm leading to expand renter assistance, was passed unanimously! A favorable vote on the House floor will send these important guardrails to the governor's desk.

Abortion Bills in the Senate: On May 4th, 150 people testified for almost 9.5 hours in The Senate Finance Committee heard 9.5 hours worth of testimony last Tuesday from about 150 people, and a total of about 220 individuals signed up to testify. Legislation to restrict access to reproductive healthcare continues to make its way through the Senate and we need to remain vigilant in educating our communities on why these bills are dangerous. American Rescue Plan Community Event: I joined 603 Forward, Rights & Democracy, NH Youth Movement, and Granite State Progress last Thursday to discuss what the American Rescue Plan will provide for our state and how we move forward. A big shout out and thank you to our NH Delegation for securing over \$1.4 billion in state and local relief funding through the ARP! Our county will receive \$60,000,000, including \$12,000,000 for Portsmouth—crucial relief to help our communities recover. It will save programs, create new jobs, and support struggling families as we continue to move forward.
