## **Voting Period**

The ballot, if required, will open at 9:00am (AWST) on 3/09/2018 and close at 5:00pm AWST on 25/09/2018.

## **Scrutineers**

A candidate shall be entitled to appoint, by notice in writing to the Returning Officer, another person to act at his/her own expense as a scrutineer on his/her behalf.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
