**PLEASE NOTE:**

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

**Withdrawing Nominations**

Nominations cannot be withdrawn after 5:00 pm AWST on 07/03/2019.

**Voting Period**

The ballot, if required, will open on 01/04/2019 and close at 5:00 pm AWST on 23/04/2019.

**Scrutineers**

A candidate shall be entitled to appoint, by notice in writing to the Returning Officer, another person to act at his/her own expense as a scrutineer on his/her behalf. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
