



ATTACHMENT 1

Any and all records or reports in your custody and control, including but not limited to, emails, correspondence, notes, documents, spreadsheets, photographs, videos, statements, payroll records, and/or schedules, related in any manner to:

1. Any and all plans the City has created for providing Fixed Base Operator (FBO) functions it is taking over from American Flyers Flight School (American Flyers) and Atlantic Aviation of Santa Monica, LP (Atlantic).
2. The names of each and every City employee who is or will be providing flight instruction services on and after October 15, 2016.
3. The airman certification status of each and every City employee who is or will be providing flight instruction services on and after October 15, 2016.
4. Any limitations or restrictions with respect to the time of day the City is or will be providing flight instruction on and after October 15, 2016.
5. The location on the airport where the City is or will be providing flight instruction, including but not limited to areas where pre-flight training, and post-flight instruction is or will be provided, on and after October 15, 2016.
6. The City's arrangements for maintaining flight training records and files for flight training the City conducts or will be conducting on and after October 15, 2016.
7. The equipment the City is or will be using to provide flight instruction on and after October 15, 2016.
8. The Airworthiness certificate and registration for each aircraft the City is or will be using for flight instruction on and after October 16, 2016.
9. Written materials, including but not limited to manuals, aeronautical charts, syllabi and training aids, that the City is or will be using to provide flight instruction on and after October 15, 2016.
10. The arrangements the City has made with respect to the maintenance of the equipment it is or will be using for flight instruction.
11. The types of aviation-related maintenance the City is or will be performing on and after October 15, 2016.
12. The names of each and every City employee who is or will be providing aviation-related maintenance services on and after October 15, 2016.
13. The airman certification status of each and every City employee who is or will be providing aviation-related maintenance services on and after October 15, 2016.
14. The location and types of facilities on the airport where the City is or will be providing aviation-related maintenance services on and after October 15, 2016.
15. Any limitations or restrictions with respect to the time of day that the City is or will be providing aviation-related maintenance services on and after October 15, 2016.
16. Arrangements the City has made or will make to ensure access to documents and data required for the performance of aviation-related maintenance, including but not limited to Manufacturer's Maintenance Manuals, Instructions for Continued Airworthiness, and Airworthiness Directives, for each and every aviation-related maintenance service that it is or will be performing on and after October 15, 2016.

17. Arrangements the City has made or will make to ensure employees performing aviation-related maintenance will have access to the appropriate tools required to perform aviation-related maintenance on and after October 15, 2016.
18. A description of the types of fueling services the City is or will be performing on and after October 15, 2016.
19. Details, plans, records, or similar documentation demonstrating how the City is or will be providing fuel services in compliance with FAA regulations and the applicable standard of care on and after October 15, 2016.
20. Arrangements the City has made with fuel suppliers to procure fuel to provide fueling services on and after October 15, 2016.
21. The names and the number of City employees who are or will be providing fueling services on and after October 15, 2016.
22. Any training City employees providing fueling services on and after October 15, 2016 have received or are receiving to provide such fueling services.
23. The equipment, such as trucks, pumps, tanks, and hoses, the City is or will be using to provide fueling services on and after October 16, 2016.
24. The City plans and procedures for providing fueling services on and after October 15, 2016, including but not limited to how fuel is transported, stored, and delivered to aeronautical customers.
25. The City's plans and procedures the City's plans and procedures for complying with all applicable local, state, and Federal regulations and the applicable standards of care related to the storage, transportation, and delivery of fuel when providing fueling services.
26. Records of airport vehicle operator training provided to or that will be provided to City employees who provide services at the airport on or after October 15, 2016.
