SAVE created and deployed the PSA: "Family is Everything" featuring Congresswoman Ileana Ros-Lehtinen and her family, including her transgender son, generating national media attention. We also developed and tested our Prejudice Reduction model in-depth conversation, scientifically proven to reduce anti-LGBT prejudice.
