
### **SAVE Marrickville**



#### Save Marrickville Community Survey on MIRVAC Carrington Rd Development

#### **Purpose**

Save Marrickville has two positions on the Carrington Rd Community Reference Group run by MIRVAC for the purpose of community consultation. The reference group was asked a number of questions, and to provide a community view on these questions, Save Marrickville developed a survey. The survey was sent to community members on our mailing list. This report is a summary of the results of the survey.


#### The survey had ten questions:

- 1. Are you aware of the proposed changes to the Carrington Road industrial precinct?
- 2. Which of the following industries operating in the Carrington Rd precinct are you aware of?
- 3. Are you aware of Carrington Road's industrial heritage buildings?
- 4. Carrington Road is home to over 200 enterprises, 15 functional clusters (eg. theatre, circus & performance art / micro-makers / food & beverages) providing approximately 1800 jobs. Would you like to see this use change?
- 5. Do you travel via Carrington Road?
- 6. If you answered Yes to Question 5, how often do you travel along Carrington Road?
- 7. What do you think about the traffic on Carrington Road?
- 8. How would you like Carrington Road to be used in the future?
- 9. Which group should have the most say in decisions regarding Carrington Road
- 10. Please add any further comments regarding the Carrington Road precinct, proposed rezoning for high-rise and development.

#### **Survey Results**


351 people completed the survey.

### Q1 Are you aware of the proposed changes to the Carrington Road industrial precinct?




"Developers will use the cost of rectifying the flooding to create a very dense residential development in an area that has only single roads in and out, above and beneath a railway line. These access points will not be widened with this development and will cause a bottle neck which will affect all side roads leading onto Carrington including Unwin's Bridge Rd Tempe and Bayview Ave Earlwood while destroying the jobs and cultural area that exists now. I completely disagree with the rezoning of Carrington Rd."

### Q2 Which of the following industries operating in the Carrington Rd precinct are you aware of?




#### Q3 Are you aware of Carrington Road's industrial heritage buildings?




Those who answered yes, were asked to name the heritage buildings. 96 people (27%) named 10 Carrington Rd as a heritage building, and 76 of these people were able to name this as the General Motors/Holden building. Eight respondents noted the Odyssey Jeans or Sydney Props building (respondents may group this with the GMH building adding another 8 people recognising this building as significant). 40 respondents noted the New Directions Building and eight, the pumping station. Both are located on Carrington Rd but are not located on the Mirvac site.




#### Q5 Do you travel via Carrington Road? Please tick all that apply



Q6 If you answered Yes to Question 5, how often do you travel along Carrington Road?




### Q7 What do you think about the traffic on Carrington Road? (Please rank 1 most frequent to 4 least frequent)




"The traffic getting onto Carrington road from side streets is gridlocked in the morning and afternoon can take half an hour to get km to princess highway from corner of Renwick St. and Carrington road. Even outside peak hour ie 9am it can take 15 minutes to get 500m towards unwins bridge road. It is absolute disaster to add multiple new dwellings /apartments as this will be totally unsustainable."
