### **Introduction**

UnionsWA Inc. regards the privacy of members, supporters and donors as an important part of our relationship with them. The following privacy policy applies to all UnionsWA Inc. users, as well as those engaged through the Save Our Services campaign (a trading entity wholly managed by UnionsWA Inc.) and conforms to Internet privacy standards.

### **Collection of Information**

In order to use the Save Our Services and UnionsWA websites, we may require information from you in order to provide the best service possible.

All correspondence may also be collected and stored, particularly in regard to donations, sales, support and accounts, including email.

Any information collected by UnionsWA on behalf of Save our Services is collected via correspondence from you or your company. This may be via the telephone, Email, mail, fax or directly through our website.

### **Use of Collection Information**

Any details collected from Save Our Services and UnionsWA supporters, donors or customers is required in order to provide you with our products and/or services, and a high level of customer service.

Correspondence is recorded in order to provide service references, and to assist in our staff development.

### **Storage of Collected Information**

The security of your personal information is important to us. When you enter sensitive information (such as credit card numbers) on our website, we encrypt that information using secure socket layer technology (SSL). When Credit Card details are collected, we simply pass them on in order to be processed as required. We never permanently store complete Credit Card details.

### **Access to Collected Information**

If you make a donation or purchase a product or service from us, we may request certain personally identifiable information from you. You may be required to provide contact information (such as name, Email, and postal address) and financial information (such as credit card number, expiration date).

We use this information for the purposes of processing donations or billing purposes and to contribute towards an aspect of our campaign for which you have made a donation or to fill your order(s). If we have trouble processing an order, we will use this information to contact you.

### **Communications**

Save Our Services and UnionsWA uses personally identifiable information for essential communications, such as Emails, accounts information, and critical service details. We may also use this information for other purposes, including some promotional Emails. If at any time a customer wishes not to receive such correspondence, they can request to be removed from any mailing lists by emailing us at [info@saveourservices.com.au](mailto:info@saveourservices.com.au).

You will be notified when your personal information is collected by any third party that is not our agent/service provider, so you can make an informed choice as to whether or not to share your information with that party.

### **Third Parties**

Save Our Services and UnionsWA may at its discretion use other third parties to provide process donation or other essential services on our site or for our business processes. We may share your details as necessary for the third party to provide that service.

These third parties are prohibited from using your personally identifiable information for any other purpose. Save Our Services and UnionsWA do not share any information with third parties for any unknown or unrelated uses.

### **Legal**

We reserve the right to disclose your personally identifiable information as required by law and when we believe that disclosure is necessary to protect our rights and/or comply with a judicial proceeding, court order, or legal process served on our Website.

## Save Our Services and UnionsWA Security Policy

**UnionsWA Inc., trading as Save Our Services uses the eWAY Payment Gateway for its online credit card transactions. eWAY processes online credit card transactions for thousands of Australian merchants, providing a safe and secure means of collecting payments via the Internet. All online credit card transactions performed on this site using the eWAY gateway are secured payments.**

- Payments are fully automated with an immediate response.
- Your complete credit card number cannot be viewed by Save Our Services or UnionsWA or any outside party.
- All transactions are performed under 128 Bit SSL Certificate.
- All transaction data is encrypted for storage within eWAY's bank-grade data centre, further protecting your credit card data.
- eWAY is an authorised third party processor for all the major Australian banks.
- eWAY at no time touches your funds; all monies are directly transferred from your credit card to the merchant account held by Save Our Services and UnionsWA.

#### **Refund & Returns Policy**

If for any reason you are not completely satisfied with your purchase or decide that you no longer wish to make a donation, we will give you three days to access a money-back guarantee from the time you receive the goods or made a donation. This refund policy does not apply to goods which have been worn or used, damaged after delivery, or if any attempt has been made to alter the product or if they have been dropped or broken. All products must be returned in their original condition. All postage and insurance costs are to be paid by the buyer.

We recommend that you return the product via Registered post and that you pre pay all postage. You assume any risk of lost, theft or damaged goods during transit & therefore advise you take out shipment registration of insurance with your postal carrier. UnionsWA Inc. will not be responsible for parcels lost or damaged in transit if you choose not to insure.
