Today's Top Three Things to Know:

1. Benefits

- a. Red Cross Blood Drive scheduled at the Government Center for April 10, 2020 **cancelled** due to new social distancing requirements. Please contact the Red Cross directly for donation locations.
- b. BurnAlong Fitness & Wellness App Launching April 1, 2020: BurnAlong is an online platform and mobile app that connects employees and their family members with instant access to on-demand and live video classes from 100's of instructors spanning 45+ health and wellness categories for kids, adults and seniors. The BurnAlong platform will be available to Fairfax County Government employees and 4 family members, at no cost.
- c. Retiring soon? Social Security Administration Offices closed to the public on March 17, 2020, but they are still working. While most of their services are available on-line, act early. If you are retiring in the next 4 months and are over 65 years of age, you must have Medicare Part A & Part B coverage in effect the day you retire to continue coverage with the County. 2. Admin Leave – Pandemic (L202) & Families First Coronavirus Recovery Act (FFCRA)

Guidelines pertaining to the use of Admin Leave – Pandemic (L202) will continue to evolve as the Department of Labor expands guidance on the FFCRA which goes into effect April 1.
