

# **Bargaining Bulletin No. 8**

## **Canadian Blood Services**

Greetings Sisters and Brothers,

After the CBS membership voted overwhelmingly to reject the Employer's latest offer on June 8<sup>th</sup>, we updated you all on your bargaining committee's next steps on the 18<sup>th</sup> of June. The committee met with the Employer to present them with a proposal to resolve collective bargaining successfully. However, the Employer refused to consider our proposal, instead maintaining their last offer. We now have to consider taking further steps including job action in order to advance the members' legitimate interest and get a fair resolution to bargaining.

To be clear, the committee met with the Employer and the Government conciliator on September 14, 2021. We tabled a proposal for a six year contract from 2017 to 2023 that included the same wage increases that have been agreed at provincial health care bargaining, 0%, 0% 1%, 2%, 2% and 2% and a signing bonus of \$1000.00 for all employees on staff at the time of signing. We also modified our previous non-monetary positions but maintained proposals to deal with hours of work (mandating and schedule changes), work on consecutive weekends and proposals to address Health and Safety concerns, sick notes and work of the bargaining unit issues. We pointed out that our proposal for wage increases was basically the same as what the Employer tabled in May.

We acknowledged the Employer's concern about the proposed signing bonus but pointed out that the members working at CBS had not received anything to address the risks, challenges and sacrifices of working through Covid and that accepting zeroes in 2017 and 2018 was a major concession to the Employer's demands. We also pointed out that our non-monetary proposals were modest steps to resolve significant workplace irritants and create a better working relationship for everyone.

The Employer refused to consider our proposal package. They continued to insist that any wage settlement had to mirror what another health care union received. CBS does not seem to understand that all three health provider unions receive the same remuneration package through the jointly negotiated pay equity plan.

Conciliation with a government mediator did not appear to be taken seriously by the Employer. The SEIU-West bargaining committee indicated it would go back to the members, report the bad news and talk about next steps we can take, including job action, to compel the Employer to come back to the table and get serious about concluding bargaining.
