- 1) Please describe your qualifications for the position you seek plus anything else that you'd like our members to know about you and your candidacy. Also list any endorsements you have secured from others you wish us to know about.

This marks my 40th year in public service, beginning in 1976 when I started with Representative Shirley Chisholm of Brooklyn, the first Black woman in Congress and 1972 Presidential candidate.

Through 22+ years of City service, including 8 as Supervisor, I'm proud of my record with respect to advancing the concerns of the SF Latino community. In 1993, I helped Susan Leal win appointment and then election in 1994 as the first Latina and Lesbian of color on the Board of Supervisors. In 2004, when Susan



was named SFPUC General Manager by Mayor Newsom, I lobbied hard and successfully for Jose Cisneros to be appointed to replace Susan as City Treasurer -- and he has done an amazing job with Bank on San Francisco and K2C.org that I helped to legislate with Supervisor David Campos.

I'm proud to have been endorsed by LDC when I ran for Mayor in 2011 and to have supported David Campos for State Assembly in 2014 and to have been David's 8th vote overriding Mayor Newsom's veto of due process for undocumented youth.

- 2) What do you think are the top 3 priorities/issues of the San Francisco Latino Community? And why?**

Building affordable housing in the Mission and other neighborhoods with significant Latino populations.

Protection of immigrant communities, ensuring they can thrive in our City and be protected from unjust federal interference and persecution.

Ensuring that City services, from employment to education to public safety are culturally competent, effective and able to help Latino families and individuals to prosper in this very difficult City.

- 3) What are your plans to encourage and empower the Latino Community into the Democratic political process?**

I will remain a strong advocate for Latino political empowerment -- my record is clear and abundant.

Active within LGBT Community, also proud of achievements on behalf of Transgender Latinas who face unbelievably high rates of violence, often fatal, and a lack of access to housing and employment.
