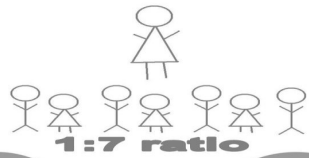

Early intervention services result in long term benefits for disadvantaged children. St. Mary's serves 280 children from all over Marion County. In addition, no child has ever been denied services at St. Mary's for financial reasons. We can change the course of a child's life.

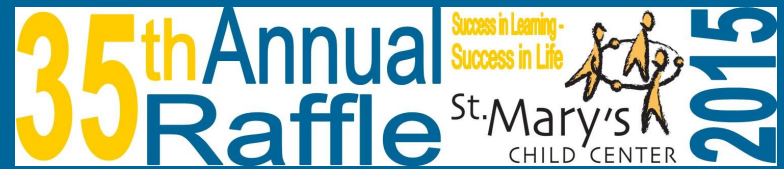
