# **General Meeting Minutes**

# April 16, 2020

## **Prior to Meeting**

- California Democratic Party Chair Rusty Hicks addressed the committee regarding keeping California Blue in 2020.
- He gave updates on finance and organizing. His number one priority is that every
  person connected to the party remains safe, healthy, and still continue to work
  on our important issues. He allowed all county parties to meet virtually
  regardless of whether or not their bylaws allowed for it. All CDP employees are
  working from home and all state offices are closed. Work has still continued.
  Yvette Martinez is our new Executive Director. She started yesterday.
- Internal dynamics: Our delegate selection process has been moved from July to August. Who knows if we'll have a national convention. We're preparing as if it is and modifying the delegate selection process. Working with DNC and all the presidential campaigns. So that the process is clean.
- We also have our own eboard process. Because the DNC dates moved, we had to move our dates as well. We had two ad hoc processes that were completed recently. ADEMS process was reformed. We also answered the question of how do we have resources for the party while adhering to the principles of the party. There is a long list of types of organizations/businesses that we no longer accept. We also have recommitted to our DEM program. We also have a Trailraiser Program now. Leaders for the party can become bundlers for the party. Amounts in the \$5K \$10K range. This is federal money. Political parties need federal money to advocate for local campaigns even. We have to get better at soliciting those kind of contributions.
- The organizing work is so important. For a long time we've been a financial organization. We need to become a more robust organizing party. One of those efforts is around the Census. We're also working with the governor's office to do wellness checks on senior voters. There are a couple million of such people. That's happening virtually throughout the state.
- We also have a virtual house party program. We want to have a thousand virtual house parties by Labor Day. Neighbors, friends, family, co-workers, whoever to meet and have a conversation and talk about their story and the county or state party story. We have a curriculum. We can help you do this.

- As we get ready for the general, there is a special election for Christy Smith on May 12. This Sunday is a Day of Action. Likely be another one closer to election.
   A brief rally virtually at 11am. Then phone calls to support Christy.
- There's been some great activity within the party despite the pandemic.
   Congrats to all that were elected or re-elected. Look forward to working with you.
- Chair Fernandez: Question from Dan Stegink. Other than money what can we do to support Biden.
- Hicks: This is a long campaign. You don't want to peak too soon. A real conversation at this exact moment is not necessarily going to have an impact closer to the election. When someone is doing something completely stupid, you let them. You see what happens with the stock market and the favor/unfavor when the current president has his press conferences. Biden is doing what he can to consolidate and unify the party. At the same time Trump is hurting himself. Might be best to let him do his thing. There's a lot of road between now and then.
- Question from Uma Krishnan: Are there any digital opportunities.
- Question from Juslyn Manalo: What strategy changes through technology will there be in our state?
- Hicks: I think this is a real opportunity. We have to get good at this virtual space.
  This moment will pass but it will stick with us. We have to get good at the
  technology pivot. Also, we don't want to leave the things we know work. Face to
  face is so valuable. We have to build an organizing and political campaign that
  operates in the virtual space.
- Karen Maki question: I signed up for a house party, when will they contact me?
- Hicks: I'll make sure someone follows up with you soon. We had about 35. We got about 90 more from those. So we'll reach out.
- Chair Rusty, Thank you for being here! can you share a little about how we expand the electorate with new voter registrations? Adding to the previous question, if Shelter in place is extended?
- Hicks: Motor voter is most common. If SIP is extended, we're likely going to see
  everyone needing a mailed ballot. The governor and secy of state are working
  though that. In LA, we weren't expecting to have everyone with a mail ballot
  until 2024. There's a push now.
