Executive Board Reports

Chair (Nicole Fernandez):

- Thank you to Erin Chazer for MCing the meeting tonight.
- We're still getting used to this format. I would appreciate any feedback. Please send to Chair and we'll improve the process. Even with some easing of restrictions, we'll be on Zoom for the forseeable future.
- Voting tonight: Recording Secretary, bylaws, and resolutions.
- Recording Secretary vote is first.
 - Chair said some very nice words about outgoing Recording Secretary, Mitchell Oster.
 - o Nominations made: Nancy Yarbrough nominates April Northrup
 - Northrup nomination seconded by Cliff Robbins
 - There were no other nominations
 - Northrup spoke for a few minutes
 - There were no objections and April Northrup was elected Recording Secretary.
- Chair asked us to do the Lightning Round at this time to discuss the important issues of the day including specifically the Black Lives Matter movement.

- Alexis Lewis spoke about the protests going on right now. The importance of raising issues. If someone raises the charge that there is racism in an institution, please listen to them. Juneteenth is tomorrow and we're still struggling to be recognized as people. Please donate to the NAACP and other organizations that work towards racial and social inequality. There is a lot of mistreatment in the world. We dismiss it so easily. These are real issues. Look at how Pres. Obama was treated. He was hated because of the color of his skin. Now we have this idiot because they hated the black man. People say "I have black friends" but do you have lunch with them or visit their house? You have to do more.
- Chair: Please let us know how we can be helping the NAACP and the entire movement. Promote events and protests.
- Chair: I'd like us to take a moment to allow people space to discuss any isssues. You can put a link in chat. Whatever you'd like.
- You You Xie: Someone said you don't to get worked up because everyone is at the table of equality. They were thinking all lives matter. But yes, we are all in it.
- Harini Krishnan: I was at the San Mateo protest when Alexis held back tears and spoke from the heart. It was poignant and beautiful. One thing I've learned in the last few weeks is how much racism there is among south Asians towards Black Americans. We're all here because of the Civil Rights movement. It allowed immigrants to enter this country. We benefit from the work of Black and Brown activists. As a South Asian American mom, we need to reach out and work together. We are talking with SALT to have a toolkit to do the work of listening with intent and honesty and not talking over and allowing space for others and listening.
- Diana Reddy: One of the messages that has resonated with me is that white
 people have to stop being silent. Alexis is making a good point about listening
 and creating space to not talk over and crowd out. We need to stand up with our
 communities of color. I'm fond of saying no life matters until all black lives matter.
- Andrea Reyna: Public education is my realm and we have an opporunity to look
 at white supremacy culture in our schools. An issue is the school to prison
 pipeline. They are putting cops into our schools. We need to redirect resources to
 services that help students and not priortize arresting students. Show up at
 school board meetings and insist that budgets reflect our values.
- April Vargas: I appreciate what everyone is saying. I saw a zoom meeting with President Obama regarding community policing. There are a lot resources including the Obama Mayors pledge. I shared that with Half Moon Bay and a city councilmember is going to look at it. The city of Burlingame is signing on. We need to talk to the cities that contract with the county sheriff. This is something that I'm really interested in.
- Sandra Lang: Thank you for mentioning the progressive caucus seminar. A lot of our problems were addressed in that. What I took away was that, Shirley Weber, Barbara Lee and Maxine Waters spoke, a lot of the information about institutional racism. It was discussed for 2.5 hours. Rep. Waters spoke about LA.

And their police unions. Their recruitment and training. This happens at the local level. Please see the recorded seminar. Thank you Alexis for bringing your own experience. I believe we can march all we want, but we have to work in our local police departments.

- Jon Levinson: We're very lucky that two momentous decisions made this week. So important that the Chief Justice is showing his soul.
- Nick Akers: I was also pleased that several local police depts took up use of force issues. We have to have law enforcement oversight in our endorsments proceess.
 We can't let this moment of focus pass.
- Chair: It's going to take all of us to do this work and I'm grateful for the leadership Alexis has shown. Thank you for your thoughts. Please continue to add to the chat.
- Regular Eboard report: Committee assignments went out. I'm very open to ideas.
 We have a climate change and farm worker committee now. If you want changes, please let me know.
- New members and alternates. Your annual dues are to be paid by July. If you are out of good standing, you can't vote.
- Leadership vacancies: Thank you to Denton for stepping in to the Finance Committee. April Vargas will be our California day of action person.

Standing Committee Reports

Finance (Nancy Yarbrough & TJ Glauthier, Co-Chairs):

 Nancy: I've called for our committee to get together soon. With the change with Covid we probably want to look at the 2021 budget. Thanks to Denton for joining.

Events & Development (Harini Krishnan & Nancy Yarbrough, Co-Chairs):

Harini: We're doing a lot with Biden. One idea was having an SMC Dems virtual
phone bank. These have been very successful. Or a virtual house party/day of
action. I can coordinate and set up a date. It can be done over zoom. Anyone can
come on, make calls, and leave. Don't have to stay on the entire time. With
Zoom, it's a limited commitment. Making the calls is very easy.

Resolutions (David Burruto, Chair):

- David: Two resolutions today. Agenda order is the Collins resolution first. The committee sat with it. Discussed using the community colleges resources. The committee is unanimously opposed. Some of the recitals, pricing out of county residents seems not too high. The last item seems to be wrong because the bond measure doesn't need to be specific so the allegation suggests that the decision was made in secret. It wasn't. It seems like an assault on the community college district. These are well loved institutions. The board has been trying to grapple with this issue. It seemed like this was a hostile allegation or series of allegations against our family in that they are well known to us. If our committee members want to express your opinion, please feel free.
- Chair: Thank you for that. Does Mr. Collins wish to speak?
 Bill: The reso is not meant to be hostile. The board is trying to do a good job.
 They've had a contract that is expiring. They want to not have that hired out. We would rather they use union workers and keep costs down.
- John Pimentel: This is not hostile. We don't want this to be a single bid situation.
 The community colleges can be a great resource. We think the entire community
 can use the campuses. Might bring more students in. The emphasis is on using
 tax payer paid facilities to benefit everyone not just those who can afford the
 fees.
- Discussion: Diana Reddy asks opinions from Union members on the resolution. That piece of the reso resonates with me. The thought of a non profit group being brought in. I'm interested in the resolution committee's view.
- Burruto: There's been a number of articles. I also spoke with Trustee
 Mandelkern. I hope you can speak on this. The number of positions that are
 union is very few. Mostly students work there. The board is trying to do exactly
 what the reso asks. With covid, this has been a much more difficult issue. They
 are doing a one year extension to next year. So it isn't a question of the board
 doing anything that isn't consistent on this point.

- Chair: Can Trustee Mandelkern speak?
- Trustee Mandelkern: The majority of board is not in favor of a single source bid. We've asked for a rfp. We actually asked that the extension be less than one year. We've asked for a report for shorter. I've asked for 10 years for this to not be outsourced. We have staff who are union and it can be done. It's easy to talk about social justice, class equality, etc. but it's hard to do it when it's costs from the budget you're approving. Fees are under the board's control. They range from \$29 to \$79. If they are too low, we compete with local businesses but also if too high we limit access.
- Erin Chazer: I want to thank Trustee Mandelkern who has been a friend to labor.
 We want union jobs whenever possible. This resolution does speak to that. We want to make economic justice seriously when we look at these things.
- Alexis Lewis: I felt this was an argument shouldn't be settled by us. Our involvement wouldn't help. I think the fight has to be taken somewhere else. Having the Dems to take a position on this was unfair.
- Helen Wolter: This has been a helpful discussion. I want to support labor. But in recreation things are very expensive. I'm wondering if the financials make sense to possibly have a sliding scale. So you can create labor positions and access.
- Trustee Mandelkern: June 24th meeting. Please attend. I don't know that this is the forum for the finances of the athletic club.
- Chair: I am going to pass to Andrea R.
- Reyna: I would like to move to support the Collins resolution. Collins seconds.
 Roll Call Vote. Resolution does not pass. Vote is 8 in favor, 13 against, with 7 abstentions.
- Black Lives Matter Resolution passes unanimously.

Bylaws (Cliff Robbins, Chair):

• This statement is a shorter and more direct with also an acceptable amendment. There was a first reading of the Code of Conduct amendment. There was a broad discussion of the issue of "sex" and "gender" and the terms "gender identity" and "gender expression" raised by Andrea Reyna and the Chair directed the chairs of the Bylaws committee to reach out to Andrea to ensure that all appropriate language be included in our bylaws amendment. Chelsea Bonini made the point that our document needs to be at least as inclusive as the state party's. But it can be more inclusive.
