7:40 PM - Executive Board Reports

- Chair Maki reports the following updates:
 - She stated that we have a special meeting tonight. The first half hour
 of our meeting will be a regular business meeting followed by an hour
 and half team building session led by Anne Adams. This session will be
 open to elected members and eboard members only.
 - She stated that an FPPC complaint has been filed against the San Mateo County Democratic Party. Our attorney is working on a response. The E-Board and few other Party leaders have advised her and reviewed our actions. The response will be submitted next week. Until the matter is resolved, our attorney has advised her not to say much.
 - On Tuesday July 13th, CADEM offered their first JEDI training in a series of six sessions. She attended and found it useful. They provided

- information about microaggressions how to recognize them, how to deal with them, and how to respond to the actor. The next session will be on July 27th. Each session is different and they aren't going to be recorded. She recommends that others attend.
- She said the June budget is in the July 15th meeting folder and said
 Not much has happened since last month. She referred questions to
 Denton Murphy.
- She mentioned that CADEM is ramping up their NO RECALL activities.
 They are hosting a phone bank on July 26th. They are creating lawn signs and precinct walking materials.

 - 2. Reach out to your neighbors with information on why they should vote No on Recall. The committee will provide materials and a list of Democratic households in your neighborhood.  - 3. Contact new and infrequent voters to make sure they receive their ballots and know how and when to return them so their No on Recall votes will count. These are easy calls and those we contact are extremely appreciative. The committee is focusing on LatinX communities within SMCo. We need English and Spanish speakers. 7:50 PM - Eboard Member Requirements Bylaws Amendment

 Andrea Reyna, Co-Chair of the Bylaws Committee, shares a first reading of an amendment redefining which members could serve on the Central Committee's E-Board.

A. Election

Officers of the Committee shall be elected at the regularly scheduled meeting of the Committee in January following the certification of the Primary Election results. Only Elected Members (including any Members appointed to fill a vacancy as provided in Article III, Section 6) and the Alternate Members of an Elected Members may serve as officers of the Committee. For the avoidance of doubt, Ex-officio Members, Alternates of Ex-officio Members, and Associate Members shall not serve as officers of the Committee. Officers of the Committee shall serve until such time as they resign, are removed, cease to be an Elected Member or Alternate Member of an Elected Member, or their successor is elected. The outgoing Chair shall be responsible for calling the reorganization meeting and for holding the election of officers.

7:55 PM - SB9 and SB10 Resolutions

- Nicole Fernandez read and moved resolutions to support SB9and SB10. Andrea Reyna called the question, and the motion is seconded by Rudy Espinoza. With 21 ayes, 3 nays, and 3 abstentions in support, the resolutions pass.

San Mateo County Democratic Central Committee Resolution in Support of the California HOME Act (Housing Opportunity & More Efficiency), S.B. 9

WHEREAS the County of San Mateo, with one of the highest costs of living in the US and in the State of California, is in a severe and prolonged housing and affordability

crisis, with an estimated 1.8 million new homes needed by 2025 in order to meet demand, yet on average only 80,000 new homes are built per year; and

WHEREAS the housing and affordability crisis continues to be a major source of stress on San Mateo County and California's fiscal health, social welfare, medical, and public safety systems, and places an unnecessary burden on our most vulnerable populations, while disproportionately harming low-income families, putting them at greater risk for housing instability and homelessness; and

WHEREAS the most effective way to address these issues is to provide more homes, that are affordable to low- and moderate-income families; and

WHEREAS housing is a human right and the need for housing stability provides the basis for educational health, and economic outcomes; and

THEREFORE, BE IT RESOLVED that the San Mateo County Democratic Central Committee supports the California HOME Act (Housing Opportunity & More Efficiency), S.B. 9, calling upon the Governor and the California Legislature to rectify California's housing crisis, expand opportunities for existing homeowners to build equity, create new homeownership opportunities for those locked out of the market, allow for lot splits, and the legalization of duplexes; and

THEREFORE, BE IT FURTHER RESOLVED that a copy of this resolution be provided to Assemblymember Marc Berman, Assemblymember Kevin Mullin, State Senator Josh Becker, State Senator Scott Wiener, and Assemblymember Phil Ting.

San Mateo County Democratic Central Committee Resolution in Support of Local Control for Increased Housing Density, S.B 10

WHEREAS the housing and affordability crisis is a major source of stress on San Mateo County and California's fiscal health, social welfare, medical, and public safety systems; and places an unnecessary burden on our most vulnerable populations, while disproportionately harming the low-income families, putting them at greater risk for housing instability and homelessness; and

WHEREAS the ongoing climate emergency is exacerbated by the lack of affordable and moderate income homes close to jobs, creating urban sprawl, increasing vehicle miles traveled, while increasing traffic and accidents; and

WHEREAS housing is a human right and the need for housing stability provides the basis for educational, health, and economic outcomes; and

WHEREAS Senate Bill 10 will support helped local governments that choose to restore "missing middle" or "gentle density" options to their mix, enabling cities to zone for

naturally affordable homes, while improving the quality of life by reducing traffic and commute times and creating communities that can sustain walkable services; and

THEREFORE, BE IT RESOLVED that the San Mateo County Democratic Central Committee supports S.B. 10, calling upon the Governor and the California Legislature to rectify California's housing crisis, by helping local governments to zone up to 10 homes on qualifying sites through local discretion; making it faster, less expensive, and less risky for a city to undertake a community process to increase density in our neighborhoods; and creating a path to address the housing shortage through the the traditional development pattern of incremental density built by many hands; and

THEREFORE, BE IT FURTHER RESOLVED that a copy of this resolution be provided to Assemblymember Marc Berman, Assemblymember Kevin Mullin, State Senator Josh Becker, State Senator Scott Wiener, and Assemblymember Phil Ting.
