

My Friend Jo Cox



On Thursday 16th June, Jo Cox was murdered doing what she has dedicated her life to: serving the people.

Before entering Parliament, Jo fought tirelessly for the most vulnerable and disadvantaged around the world. And in her year in Parliament Jo showed tremendous leadership, standing up for the Syrian people, working across party lines, bringing people together, and making the world a better place.

Jo never stopped fighting for what is right, and for those who needed a voice. She exemplified not only the best values of our Party, but also of our country: internationalism, compassion and solidarity.

In the year that Jo and I have been in Parliament together we have shared an office and many good times together. For me, our little corner of Portcullis House will, quite simply, never be the same again.

I'll miss Jo's raucous laugh, her infectious good humour, her relentless optimism and her relentless tenacity.

Today, not only have the people of Britain lost one of the best MPs we have, not only have I lost a dear friend, but most tragically, Jo's family have lost a loving mother, wife and daughter.



Those saying we must 'take our country back' need to realise the consequences

There are those who say we must "take our country back", who castigate those on one side of an argument as an "elite", in the pay of an establishment, in it for themselves and detached from the real world. Those people have to realise that their aggressive words and dangerous rhetoric have consequences. If you try to light a fuse, you can't be surprised when it catches.

I have never known anyone less in it for themselves than Jo. She cared about our place in the world because she cared about the lives of the real people that she had committed herself to serving. She believed in unity over division, a sentiment she conveyed so beautifully in her maiden speech just a year ago.

And she had been actively campaigning in recent weeks for our place in the world as an open, tolerant and generous nation. Just as she fought for our values as a nation when advocating for refugee children and those caught up in the Syrian conflict, so she fought for our values and place in Europe.

EU Opposition Day Debate

I delivered a speech in the commons for the opposition day debate on the EU. An extract is below, you can see my full speech on my website at http://bit.ly/28QbCSY

The decision facing the electorate on 23 June is a choice between economic security and global influence inside the EU or a leap in the dark outside it, and nowhere will the consequences of that choice be more deeply felt than in my constituency, where the Port Talbot steelworks is the beating heart of our economy and community. I was therefore pleased to see that this week Tata Steel UK sent an all-staff communication stating:

"The European Union influences very important aspects of Tata Steel's business in the UK. The EU is by far our largest export market, with over a third of our UK steel heading there. And that's not including the steel that goes via our customers—the EU is a critical export market for the UK's car makers for example. So access to that market is fundamental to our business and one of the preconditions for this trade is that EU laws and regulations are followed. If the UK were to exit the EU and set these rules ourselves, it is likely we would still need to adhere to EU rules to enter that market. The difference: we would no longer have a say in how those rules are set up or applied."

We know that the British steel industry is in a precarious state. The last thing it needs now is the turmoil that would be unleashed by a Brexit. That is why I am looking forward to once again joining steelworkers in Aberavon town on Saturday to send the message loud and clear that the steel industry is stronger, safer and better off inside the EU.



Save Our Steel Protest

Thousands of steel workers marched on Parliament to deliver a clear message to both government and Tata: that they must Save Our Steel. I was proud to stand with them.

The Tata board meeting in Mumbai, on the same day, should have brought greater certainty to the sale process, but we are left pretty much where we were, with no short-list announced. Ending this ongoing uncertainty is essential.

It is crucial that Tata Steel make good on their promise to be a responsible operator and seller, and that whoever is the owner at the end of this process manages the transition in a manner that will command the loyalty, trust and respect of the workforce.



That means a clear indication of the long term commitment to investment in Strip Products, the continued operation of the blast furnaces in Port Talbot and a clear and fair settlement on the pensions. The government must also now make every effort to support the UK steel industry by acting on energy costs, procurement and Chinese dumping.

Tata Pensions

I questioned the Secretary of State for Business Skills and Innovation on the Tata pensions:

'There has been some speculation in the media that Tata steel may in fact decide to retain the business, could the Secretary of State explain if that were to come, what role Tata Steel would play in this issue of the pension scheme?' http://bit.ly/25xXvFV



I also raised the issue with the Secretary of State for Wales:



'As we know, a critical meeting is taking place in Mumbai later today, and the future of the industry is hanging in the balance. What measures have the Secretary of State and his colleagues in the Cabinet taken to ensure that a viable and sustainable pension scheme is developed as a result of the sale of the business? Can he assure the House that it will be sustainable for the 130,000 members of the scheme?' http://bit.ly/1XOGMeU

Our economy is too unbalanced and too unstable to be resilient and to serve the British people

In the days that followed the Queen's speech I managed to make the following contribution to the debate:

'It is a pleasure to follow my neighbour, my hon. Friend the Member for Neath (Christina Rees). The Prime Minister declared this to be a one nation Queen's Speech for a one nation Government. He said that his Government were a Government for whom "economic security always comes first" He said they



were a Government with a "long-term economic plan". But, once again, we have seen nothing to substantiate those grand plans. All we have seen is stasis.

The British economy in its current state is best described by the saying, "All that glitters is not gold." At first glance there is the semblance of a positive picture, but scratch away at the surface and a very different story emerges: a story of low productivity, ballooning personal debt, a yawning trade deficit, creaking infrastructure, a dangerous over-reliance on financial services and a growing chasm between London and the rest. To put it simply, our economy is too unbalanced and too unstable to be resilient and to serve the British people. It is too short-sighted, too inward looking and far too unequal.

In my constituency, we have seen the costs of the Government's failure. For more than a year my Labour colleagues and I have called on the Government—we have raised the issue more than 230 times since the general election—to snap out of their stupor and take action to stand up for British steel. We were met with a mixture of indifference and incompetence. Only when the crisis became a PR problem did the Government wake up and seek a last-minute fix to a problem that we have pointed to for a year. The steel crisis really sums up the Government's approach: it is a problem only when it hits the front pages. If the Government had a real long-term economic plan and a real strategic approach to governing Britain, the crisis could have been averted. Instead, we have a Government with a long-term economic plan that is not a plan at all but a bookkeeper's to-do list. They are focused only on reducing costs without giving any thought to the generation of revenue through sustainable growth. They think that the solution to everything is to reduce the size of Government and retreat from the challenges of the future rather than addressing the faulty foundations of our economy.

That is why the Queen's Speech was yet another missed opportunity, and that is why I shall vote against it this evening. http://bit.ly/25xXOQZ


Cwmavon Coffee Morning




Toe-to-toe with Iain Duncan Smith
