Since then we have met with Karl-Ulrich Köhler, Chief Executive of Tata Steel Europe

#### Swansea Bay Tidal Lagoon

It was encouraging to hear the Government give the go-ahead for the Tidal Lagoon in Swansea Bay. The social and economic benefits to our constituents make this project so much more than a great leap forward. I have written to Amber Rudd MP, Secretary of State for Energy and Climate Change, calling on the Government to make progress with the remaining decisions so that construction can begin at the earliest opportunity so the social and economic benefits of the Lagoon can begin as soon as possible.

### Beast of Bryn

Great to run in the Beast of Bryn again this year and raise money for Cystic Fibrosis at the same time. The organisers did a great job and the event was a real success again.



### Queen's Speech

The Queen's Speech, the Government's legislative programme for the year, set out a number of headline policies:

- EU Referendum Bill to be held by the end of 2017. (I have joined the 'Pro-EU' group of Labour MPs, chaired by Pat Glass MP, and I fully intend to play an active and committed part in the 'In' campaign).
- Full Employment And Welfare Benefits Bill will reduce the benefit cap to £23,000 and remove the automatic entitlement to housing support for 18-21year olds.
- Personal Tax Allowance raise the personal tax allowance to £12,5000.
- National Insurance Contributions / Finance Bill no rise in income rates, VAT or National Insurance contributions.
- Immigration bring in greater controls of immigration.
- Trade Unions Bill all strikes must be the result of "clear, positive and recent" decisions by union members. The must be a 50% turnout with 40% in favour of action in essential public services such as health, education, fire and transport.
- State Pension continuing the triple lock.
- Wales Bill giving greater clarity over the division of powers between the Assembly and Parliament. Devolve more powers over energy, transport and local government.
- English Votes For English Laws allowing decisions affecting only England or England and Wales to be taken by the majority of MPs representing these constituencies.
- Extremism Bill strengthen powers to stop extremists promoting views and behaviours that undermine British Values.
- Psychoactive Substances Bill making the production, supply, offer to supply, possess with intent to supply, import or export legal highs an offence.
- British Bill of Rights to be brought in to replace the Human Rights Act.
- Housing Bill giving tenants of housing associations the right to buy their own homes.

Although the Housing Bill is an England only bill it is important to note that the policy is coming apart at the seams with criticisms including it fails to address the shortage of housing and compensation would need to be paid to Housing Associations who would be forced to sell their stock to tenants at below market rates.
