## INFORMATION ON REQUIREMENTS FOR CANDIDACY AND PETITIONS

### REQUIREMENTS:

Office of Township Council - Candidates must be registered voters and residents of the Township of Sparta.

#### PETITIONS:

### Must be filed on or before 4:00 p.m. - September 6, 2016

Each signature shall be on a separate petition sheet and shall bear the name and address of the petitioner and shall be for no more than one candidate.

The candidate for office and his campaign manager shall file an oath that the statements made in the petitions are true and that each signature appended thereto is the genuine signature of the person whose name it purports to be to their best knowledge and belief.

#### AMENDMENTS TO

PETITIONS:

Petitions may be amended for defects until September 8, 2016. No names may be added. Municipal Clerk makes determination on sufficiency of petitions filed.

#### NUMBER OF PETITIONS

REQUIRED:

One percent (1%) of the registered voters in the Township of Sparta (141 petitions needed, 151 provided in case of errors.)

In the event individual petitions of nominations must be discounted, it is suggested additional petitions over and above the required number be obtained for submission.
