Dear Mr Williams

Thank you for your request for information pursuant to the Local Government Official Information and Meetings Act 1987. Specifically, you have requested information relating to an event hosted by Wellington City Council on 6 July 2016.

Background

The Wellington City Council (Council) and the Australian Capital Territory Government (ACT) have been working, since late February, to develop and implement a sister city relationship.

You may be aware that Singapore Airlines will commence flights from Singapore to Canberra and Wellington on 21 September this year. In light of that, the Council and ACT have worked to ensure that both cities are able to leverage off the significant economic benefit this presents. The flights alone, according to Wellington International Airport figures, will inject an additional \$95 million spend into the New Zealand economy per annum, with an estimated \$44 million contribution to the nation's GDP.

This work culminated in the signing of the sister city agreement between Wellington and Canberra and this significant and mutually beneficial relationship was celebrated at the event on 6th July. This event brought together three key elements; the acknowledgement of the new relationship, an urban activation approach to showcasing the former Public Trust Building and marketing Wellington.

Sister City Agreement

As you have noted, the Mayor and Council have promoted the establishment of the agreement between the two cities. While you have not asked for a copy of the agreement, we have included it for your reference as it provides context for a range of activities associated with its implementation.

The agreement has been developed to focus on delivering benefit to both cities. It is not, therefore, simply an acknowledgement of association - it is the framework for tangible outputs towards shared objectives.

The sister city agreement has already enabled agreements between the Wellington Regional Economic Development Agency (WREDA) and the Canberra Innovation Network and Zealandia and Mulligan's Flat Woodland Sanctuary.

You may also have seen that the Council hosted the signing of the Wellington and Canberra Chambers of Commerce Memorandum of Understanding as one of a number of new relationships under the sister city banner.

Since the opening of a dialogue between the Council and the ACT, work has begun to market Canberra to Wellington by *VisitCanberra*, which launched its campaign here recently. That campaign, under the sister city banner, is designed to attract Canberrans to Wellington and Wellingtonians to Canberra. Importantly, collaboration around marketing activities between both cities will be part of a campaign to bring long-haul international travellers to both cities.

Like you, we think ratepayers have a right to know the total cost of the event. The event costed a total of \$51,022.45, which represents excellent value for money.

Discussion

Sister City

The Sister City agreement sets out the areas where the Council and ACT Government will cooperate to generate new activity, share expertise towards improved delivery of service and work together for mutual opportunity.

The agreement has a heavy emphasis on the economy. The agreement sets out expectations of work to be undertaken in events development, tourism promotion, marketing and product development. and the Wellington and Canberra Chambers of Commerce have also signed a Memorandum of Understanding. It creates an expectation that the two cities will work harder to connect businesses in Wellington and Canberra. However, there is also a strong focus on culture and the arts.

As a showcase of Wellington's arts, culture, digital, fashion, food and beverage assets the event brought together a wide range of performers, designers, small local arts companies, local production companies and local digital and audio companies. Many of their services were provided to the Council at heavily discounted rates in support of the event. Their support enabled us to put some of Wellington's newest emerging talent on show and enabled them to market their talent and expertise.

Urban Activation - The Former Public Trust Building

The Council is proud to have been able to, at short notice, bring together several strands of work to enable the event on 6 July at the former Public Trust Building on Lambton Quay. The Council chose to stage the event in the Public Trust Building because the recently seismically strengthened venue presented an excellent marketing and urban activation opportunity.

The Council worked with the owner who generously leased the building for the purposes of the event on 6 July. This was part of an urban activation approach that sought to show the building off and demonstrate its versatility to potential investors.

Marketing

One of the three elements of the event was that it was a marketing opportunity, and on that score it was a huge success. The ACT Chief Minister acknowledged during the event that Canberra would not yet be able to compete with Wellington for the title of 'coolest little capital in the world' – which is of considerable economic benefit to the city.

A key output from the event will be a video that will be available to WREDA, *InvestCanberra* and the Council as part of its marketing campaigns to attract business, talent and tourism in to Wellington from Canberra, Singapore and Asia.

The Council has received three sets of requests from you and I have responded to each in turn below.

Your question 1

"An [sic] programme of the event's proceedings"

"A breakdown of all costs associated with the event, including (but not limited to) venue hire; entertainment; performers, food, alcohol; speakers fees, and travel"

As noted above, the suppliers of all aspects of the event including the hiring of the venue, gave significant discounts to the Council in support of the event.

- 3. Production costs included venue hire as well as venue set-up costs such as power, waste management, logistics, rigging, security, loading, furniture and lighting as the venue is currently a shell.

"Descriptions of the nature of the entertainment, dancers, and performers at the event"

Your question 5

"Who approved the entertainment, and was the Mayor or Deputy Mayor consulted (if so, please specify which)?"

Response:

Final decisions on the event were made by officers.

Neither the Mayor nor Deputy Mayor had a decision-making role in any of the three elements of the event on 6 July as this was an operational matter.

Your auestion 6

"We are informed that the event included drag queens and toga-wearing male models feedings each other grapes. Is that correct? If so, were those drag queens and toga-wearing male models ratepayer funded and, if so, why?"

Response:

There were no "toga-wearing male models" as you advise you were informed. Those we believe you may be referring to were both wait-staff and performers, the majority were women none of whom were wearing a "toga".

The event was supported by Pollyfilla who is a well-known, professional and respected dragqueen performance artist. Pollyfilla attended the event at their own expense and was regarded as a highlight by attendees because their inclusion demonstrated the diversity, culture, fun and progressive-appeal of Wellington.

Pollyfilla's performance was well-received by the Australian delegation as one of a large number of vibrant Wellington performances. We also note the performance of ballet dancers, local fashion designers who incorporate performance in showing their clothes, two contemporary performance groups, *Illuminated Bikes*, singers, classical musicians as well as digital display.
