The Nanny State Rich List 2018

Introduction

When we last published the Nanny State Rich List, it was clear that the influence of public health organisations was increasing. In 2016, the sugar tax had just been signed into law, yet its implementation remained years away and the debate over the merits of the tax remained very much ongoing. Recent proposals however go further. The sugar tax has already seen soft drink sugar levels reduced by 11 per cent¹, now milk-based drinks are next on the list². But beyond government, stricter proposals abound. Pressure group Action on Sugar has called for high-sugar milkshakes to be banned outright³, whilst an Oxford study has suggested processed meat be taxed by up to 79 per cent⁴.

The proposed and enacted forms of taxation overwhelmingly harm those on lower incomes by increasing the costs of everyday products. These additional taxes on food and drink products merely create a prohibition by income.

This research note outlines the remuneration received by senior staff working within public health in England, Scotland, Wales and Northern Ireland. This takes into account our 2016 research under the same title to illustrate that since then public health groups have become ever more empowered within government at increasingly greater expense to the taxpayer.

Key findings:

Overall findings⁵

- Britain's 10 best paid public health employees all receive above £200,000, with 2 individuals receiving over £300,000. This is in contrast to 2014-15 when just 3 public health employees received above £200,000.
- When excluding the directors of public health in local authorities, the total number of public health employees in the UK receiving over £100,000 has increased from 223 in 2014-15 to 266.
- Featured in the Nanny State Rich List for the first time, the Director of Public Health for Northern Ireland is amongst those earning over £200,000.

Public Health England (PHE)

- PHE has 241 employees in receipt of total remuneration in excess of £100,000, an increase of 17 per cent, or 42 employees.
- The number of PHE employees earning over £150,000 has almost doubled from 7 in 2014-15 to 13.

Note the meat tax proposals are based on <u>a study</u> from the Oxford Martin School at the University of Oxford, which propose a 20 per cent tax on un-processed meat and a 79 per cent tax on processed meat.

• Whilst just 1 individual working for PHE received total remuneration in excess of £200,000 in 2014-15, that number has now quadrupled, with 4 individuals now receiving this high figure.

Public Health Wales and Welsh University Health Boards

- Public Health Wales has 7 employees on the payroll in receipt of total remuneration in excess of £100,000, 4 of whom receive in excess of £150,000. This is in contrast to just 2 employees receiving over £150,000 in 2014-15 and 5 then receiving over £100,000.
- The average salary being paid to public health directors at the various Welsh University Health Boards (UHBs) has risen to £187,583 from £124,500 in 2014-15, an average pay increase of 51% in 3 years.

Public Health Agency Northern Ireland

The Northern Irish director of public health has received a pay rise of approximately £65,000 since 2014-15 with total present remuneration of £207,500. This is in addition to 2 other members of staff receiving total remuneration in excess of £100,000.

Scottish NHS trusts

- The public health director for NHS Western Isles has seen total remuneration rise by over £50,000 since 2014-15 for the same position.
- Though not meeting the £100,000 threshold in 2014-15, NHS Dumfries and Galloway's public health director in 2017-18 received total remuneration of £152,500.
- Though the comparative image of the Scottish NHS trusts at first appears positive, NHS Greater Glasgow and Clyde, NHS Highland and NHS Tayside have not yet published their 2017-18 annual accounts and thus are excluded from this report.

Local Authorities

- Lesley Mountford, director of public health for Stoke-on-Trent City Council received total remuneration of £369,579. This included compensation for loss of office.
- On average, local authorities have reduced the amount paid to public health directors since 2014-15. There are however still 17 local authorities whose public health directors earn over £150,000.
- The top paid local authority public health directors include:
 - Lesley Mountford, who worked for Stoke-on-Trent City Council as director of public health, received £369,579.
 - As director of wellbeing, public health and communities for Essex County Council, Mike Gogarty received total remuneration of £194,020.
 - Tracy Daszkiewicz received £189,507 working for Wiltshire Council.
 - John Linanne of Warwickshire County Council was in receipt of a total of £184,270.
 - Bromley Council paid director of public health Nada Lemic a total of £183,873.
 - As chief officer for communities, public health, environment and prosperity, Virginia Pearson was paid a total of £181,462 from Devon County Council.
 - Steve Whiteman was paid £178,492 by the Royal Borough of Greenwich.

Sources and Methodology:

This report has been compiled principally by analysis of the annual reports published by Public Health England, Public Health Wales, the Public Health Agency North Ireland, regional NHS trusts and health boards and finally of local authorities. The sole use of a Freedom of Information request was to establish the number of Public Health England employees in total in receipt of over £100,000.

- Where pay has been reported within bands of £5,000, a mid-point has been shown.
- Except where explicitly stated, total remuneration is a combination of salary, pension contributions and any bonus payments.
- Where several public authorities are jointly funding the employment of a single public health director, the primary employer (where known) has been displayed.
- Remuneration figures and employee names where given are correct up to the end of the 2017-18 fiscal year.
- The term 'senior salaries' when used refers to total remuneration in excess of £100,000.
