Important Dates: Early Voting Begins September 24th and Election Day is November 3rd

Vote by Mail Ballots will be mailed on September 24th through October 29th. If the application for a Vote by Mail Ballot is received by September 24th, the ballot will be mailed to the voter no later than October 5th. For applications received after September 24th, the ballot will be mailed to the voter within 2 business days. Vote by Mail Ballots can be received at your registration address or at any other address that you specify on the reverse side.

Due to COVID-19, all 2020 General Election voters are encouraged to cast a ballot prior to Election Day, either by mail or during early voting. Voting by Mail is an easy and secure option for voters and you can request a Vote by Mail Ballot through the mail or in person.

Under penalties as provided by law pursuant to 10 ILCS 5/29-10 of the Election Code, the undersigned certifies that the statements set forth in this application are true and correct.
