Drivers join together to expand the App-Based Drivers' Association on May 5.

"I've been an Uber driver for about a year and since then a lot of things are different," said Hussein Farah, at the meeting for the App-Based Drivers' Association (ABDA) at the Teamsters Building on May 3. "With an association, when we come together we can do a lot of things."

Drivers were joined by community and elected leaders. **"My job as a city councilmember is to make sure that drivers are treated fairly,"** said Seattle City Councilmember Mike O'Brien.

At the event, drivers elected a 13-member leadership council for the coming year.

"We stand together with app-based drivers as they organize for better working conditions and fair pay," said John Searcy of Teamsters 117. "As Teamsters, we know that workers can take on \$40 billion companies like Uber and win. **Because as Teamsters, when we fight, we win.**"

INTERVIEWS WITH CANDIDATES

ABDA's leadership council got to work quickly after our meeting with the Teamsters on May 3.

In June, your leadership council met with over 20 Seattle City Council candidates who want us support their campaigns.

During the interviews, drivers educated politicians about the challenges facing app-based drivers in Seattle and asked for their support on city policies we hope to pass in 2016.
