Brothers and Sisters:

I want to draw your attention to a common concern in the public sector work environment. It's a practice called "skimming."

Skimming occurs when managers or outside contractors start performing job duties typically assigned to members within the bargaining unit. Skimming can cause you to lose out on overtime, lose control of your work environment, or even lead to layoffs.

In the South Sound region, Stewards and other members have reported skimming at the City of Tacoma, Pierce County, and other locations.

As a union member, you have protections against skimming under the law and possibly in your contract. It may be a contractual violation or an unfair labor practice, for example,

when an employer fails to bargain the decision to skim bargaining unit work.

"SKIMMING OCCURS WHEN MANAGERS OR OUTSIDE CONTRACTORS START PERFORMING JOB DUTIES TYPICALLY ASSIGNED TO MEMBERS WITHIN THE BARGAINING UNIT."

It's important that you are aware of your rights with respect to skimming and that you protect the work you have historically performed.

If you allow your employer to skim your work, it can quickly develop into

an established practice and it may be difficult to recapture that work.

If someone is performing your work who is not a member, be sure to report it to your Shop Steward or Business Representative immediately. A failure to stop skimming will weaken your union, diminish your leverage at the bargaining table, and make it more difficult for you and your co-workers to recapture your work.

New FamilyStrengthCommunity.org builds member involvement

We've just launched an exciting new website for members of Teamsters 117. It focuses on the values we share as Teamsters – values like family, strength, and community.

The site highlights our shared values – the need for wages to raise a family, strong and healthy communities, a secure retirement, and respect.

The site also emphasizes the need for us to stick together. Right now, working people are facing unprecedented attacks by wealthy special interest groups like the "Freedom" Foundation.

These groups are trying to rewrite the rules for union members in the statehouses and the courts. They're trying to make it more difficult for us to stand together and fight for what we believe in and the values we share.

The "Freedom" Foundation is bankrolled by out-of-state billionaires and wealthy special interests. They use

their vast resources to try to undermine unions. But there are a few things they don't have — our power in numbers, our unity, and our collective voice.

As Teamsters, we're strongest when we stick together. That's why we're asking members to reaffirm their commitment to each other by signing an online pledge. You can fill out the pledge on the new website.

You can also sign a pledge card at work. Shop Stewards and other rank-and-file leaders are going around the workplace, talking with members about the issues members are facing.

This is a part of our **Every Voice Counts campaign**. Over the next several months, we'll be conducting member-to-member interviews across our union.

Supreme Court Reaffirms Collective Bargaining

The U.S. Supreme Court delivered a victory to working people in its decision in *Friedrichs v. California Teachers Association*. The Court's 4-4 decision leaves intact the precedent that has served as law for four decades.

"The ruling affirms 40 years of precedent that working people have the right to a strong and effective union," said John Scearcy, Secretary-Treasurer of Teamsters Local 117.

The Friedrichs case challenged the constitutionality of fair-share fees. These are the fees paid by non-union members who share the wages, benefits and working conditions collectively bargained for them by their union. The fees are used to cover the cost of bargaining and do not go towards political activity.

What happens now?

For now, public sector workers will maintain their ability to negotiate improvements at work through a strong union.

Although Friedrichs is no longer an immediate threat, there are other groups with a clear agenda to defund and bleed unions of our ability fight for working people.

The Friedrichs case was yet another reminder of the attack on the American middle class.

Teamsters 117 public sector members are engaging with each other through the **Every Voice Counts campaign**. This campaign helps build unity through member-to-member interactions. Member engagement is the key to building a strong union.
