**DECLARATION OF MICHELLE
WOODROW IN SUPPORT OF
PLAINTIFF'S MOTION FOR
PRELIMINARY INJUNCTION**

I, Michelle Woodrow, declare as follows based on personal knowledge:

1. I am President and Director of Corrections & Law Enforcement at Teamsters Local Union No. 117 ("Local 117"). I am competent to testify before a Court of law, and I have personal knowledge of the matters contained herein.

2. Local 117 is a labor organization representing 16,000 men and women at 200 employers across Washington State.

1 3. Approximately 60 of these workers are bindery and lithography professionals
2 employed by DES, while approximately 5,400 are correctional officers and other employees
3 providing services throughout the Washington State corrections system.

4 4. The relationship between Local 117 and the State Agencies is governed by the
5 terms of their respective collective bargaining agreements as well as applicable statutes,
6 including RCW 41.06 and RCW 41.80.

7 5. On or about April 8, 2016, an agent of the Office of Financial Management
8 (“OFM”) informed me that on or about April 7, 2016, an agent of the Foundation submitted a
9 request for public records to DES.
10

11 6. The request specifically sought “[t]he first name, last name, middle initial,
12 birthdate and work email address of every current Department of Enterprise Services employee
13 represented by Teamsters Local 117.” Attached hereto as **Exhibit A** is a true and correct copy of
14 the request, as received by Local 117.

16 7. The same individual at OFM informed me that on or about April 6, 2016, Jamie
17 Lund, Senior Policy Analyst for the Foundation, submitted a request for public records to the
18 DOC that was essentially identical in nature, seeking “[t]he first name, last name, middle initial,
19 birthdate and work email address of every current Department of Corrections employee
20 represented by Teamsters Local 117.” Attached hereto as **Exhibit B** is a true and correct copy of
21 the request, as received by Local 117.

23 8. In response to the Foundation’s PRA requests, both DES and DOC have indicated
24 to Local 117 that they intend to provide the Foundation with the requested information absent an
25 injunction by the Court.



PERC Decision #9351.

b. Supervisory employees - All supervisory classified employees of the State of Washington working for the Department of Corrections in correctional institutions, the correctional industries program, the sex offender treatment program, and regional business service center, excluding persons exempt from the coverage of Chapter 41.06 RCW, employees in the Washington Management Services, confidential employees, non-supervisory employees, institutions employees in historically-excluded groups that have not been modified by subsequent orders, and all other employees of the Employer. PERC Decision # 9351.

c. Psychiatric Social Workers - All civil service psychiatric social workers in the Washington State Department Of Corrections in the institutions, excluding supervisors, confidential employees and all other employees. PERC Decision #9322.

d. Psychology Associates – All full-time and regular part-time psychology associates of the Washington State Department Of Corrections in the institutions, excluding employees at Pine Lodge and Ahtanum View, supervisors, confidential employees, Washington Management Service employees and all other employees. PERC Decision #9780.

e. Chaplains. PERC Decision #9751.

f. Psychiatrists - All full-time and regular part-time psychiatrists of the Washington State Department Of Corrections in the institutions, excluding employees at Pine Lodge and Ahtanum View, supervisors, confidential employees, Washington Management Service employees and all other employees. PERC Decision #9752.

g. Psychologist 3&4 Non-Supervisory - All full-time and regular part-time psychologists of the Washington State Department Of Corrections in the institutions, excluding employees at Pine Lodge and Ahtanum View, Supervisors, confidential employees, Washington Management Service employees and all other employees. PERC Decision #9750.

h. Psychologist 3& 4 Supervisory. PERC Decision #9760.

DOC Staff:

This email serves as official notification that the department has received 2 separate public records requests from the Freedom Foundation asking for the first name, last name, middle initial, birthdate and work email address of every DOC employee represented by both Teamsters 117 and the Washington Federation of State Employees. A copy of these requests are attached for your reference. If you are not a member of the Teamsters or Federation then these requests do NOT apply to you.

The purpose of this email is to:

1. Notify you that if you are a member of either of the above unions, then your name, work email and date of birth is a part of department records that have been requested under the Public Records Act, RCW 42.56,

2. Provide you a copy of the request, and
3. Provide you opportunity to pursue court action to stop the release of these records, should you choose to do so.

In addition, please note that given the fact that DOC is a criminal justice agency, there is an exemption found in RCW 42.56.250(8), that allows the agency to redact the month and year of employee birth dates. As such, the department intends on releasing your full name, work email address and the actual day of birth NOT the month or year.

Attached, you will find a copy of the requests we are responding to as well as general steps should you choose to pursue court action to stop the release of your name, work email and day of birth only. If you do want to prohibit disclosure of this information, you will need to send a temporary restraining order signed by the court no later than close of business Friday, May 13, 2016 to docpublicrecords@doc1.wa.gov, otherwise the requested information will be released.
