Over 200 DOC members hit the State Capitol to talk with their legislators

ver 200 Teamsters from the **Department of Corrections** converged on Olympia on January 27 for our 2015 DOC Teamsters Lobby Day. Members from all across the state met with dozens of legislators to talk about the importance of getting our DOC contract funded.

"Legislators need to understand that funding our contract is our most important priority," said Charles Cline, an officer at the Stafford Creek Corrections Center in Aberdeen.

Dana Carroll, an AC Cook at WCCW, agreed:

"We are the lone rangers that nobody sees. People don't realize the heightened anxiety that we go through every day. My family doesn't even know. I wouldn't even tell my husband half of what goes on."

Carroll and her group met with Senator

Tim Sheldon (35 LD), who pledged his support. "Our group was so big we had to meet with him on the Senate floor," Carroll said.

"It was a great experience," added Samantha Logan an officer at CBCC. "We got some good outcomes. All three legislators we spoke with said that they fully support us. They also thanked us for the work that

we do in keeping the community safe, keeping families safe, and keeping them safe. They said they admire the work that we do. It was good to hear that."

In addition to advocating for a fair DOC contract, members spoke about the need to expand the PSERS retirement program to include DOC medical staff and to pass a statewide paid sick days bill.

This goal mirrored itself in the minds of all present and those unable to physically be present but who sent their best wishes.

Our goal was to show the legislature that we are affected by the decisions they make and that we will stand up and have our voices heard. We wanted those with the ability to create change to see the true faces of corrections.

Corrections should not be viewed as a bill, a contract needing ratification, or words on a piece of paper, but rather it should be viewed for exactly what it is.

Corrections is made up of the men and women who together keep our public safe and who operate 24 hours a day, 7 days a week without the ability to hang the CLOSED sign on the window.

Corrections is made up of people who must wear different masks and facilitate different roles. Correctional employees do not have the luxury of a guaranteed return home after a long day of work but must operate with a heightened sense of awareness to deal with situations that are both dangerous and unpredictable.

Recently, six members of Teamsters 117 who work in the parking industry were reinstated after being wrongfully terminated by their

employer. The workers are part of a newly-organized group that came together seeking strong representation and a voice. As such, they don't have a contract yet or the just cause protections that a contract provides. Still, even without these protections, the group was able to pressure their employer to reinstate workers who were targeted for their union activity. How did they do it? They did it through direct action. They did it through solidarity. They did it through leafleting, wearing buttons, calling the mayor's office, and standing strong together.

DOC MEMBERS: WE HAVE THE POWER

At the DOC, members are also standing together and it's making a tremendous difference. At last month's Lobby Day, over 200 members and their families met with dozens of legislators to talk about funding our DOC contract. With the event, we achieved our best attendance for any DOC Lobby Day. The strong turnout is a testament to the growing strength of our political program. More members are understanding that we are exponentially more powerful when we get involved.

But we can do better. With 5,600 Teamsters at the DOC, we have incredible potential to affect change. We can fund our contract, expand our retirement security, pass statutory interest arbitration, and much more, but we have to get involved.

There are lots of opportunities to participate in your Union. For DOC members, a good place to start is with our **Contract Funding Strategy Sessions** that are taking place over the next several weeks. At those meetings, we'll be talking about how we can reach out to small businesses in our local communities to build support for funding our contract.

Securing the support of small businesses in our community is one more way that we can convince legislators that a fully-funded DOC contract is not just a priority, but a necessity.

In Our View

A FAIR SHAKE FOR THE CORRECTIONS **WORKERS WHO PROTECT US ALL**

orrections workers protect us all although the work they do is hidden from the view and consciousness of most Washingtonians. This difficult work involves many sacrifices, so many that our state's prison system has a serious problem recruiting and retaining qualified staff. The State Legislature has an opportunity to address these shortcomings in its current budget. In doing so, it can improve the safety and well-being of communities across our state.

Our state's corrections workers earn much less than their peers. Custody officers, the most common job classification, earn 55% less than those doing the same work in county-run facilities. Mental health counselors earn 53% less than their peers. Cooks, 39% less.

These correctional employees have not had a raise in six years, and they have seen their real earnings shrink by more than 10%. Some full-time workers' families qualify for public assistance.

These substandard wages are for hard, dangerous work. Corrections workers suffer much higher rates of depression, PTSD, suicide, divorce, heart ailments, and diabetes than the rest of us. Their rates of serious on the job injuries are among the worst in the state.

An independent arbitrator considered these facts alongside the condition of the State's finances and awarded

: corrections employees a contract with 5.5% and 4.3% wage increases in 2015 and 2016 respectively, amounts found to be fiscally feasible by the state's Office of Financial Management. It is now up to the Legislature to confirm the contract in the coming state budget.

The contract would begin to close the earnings gap between state corrections workers and their peers. It would help retain the experienced staff who are best able to prepare offenders for life after prison; high staff turnover undermines the evidencebased programing and rehabilitative work that is key to preventing recidivism. It would also help address the safety problems caused by having high numbers of inexperienced employees supervise dangerous felons.

As an additional benefit, approving the corrections contract would boost economic activity, generating \$527 million of economic activity statewide. The bulk of the economic benefits would flow to rural areas, small cities and towns that have missed out on the economic recovery.

Legislators in Olympia have the power to provide this economic boost, improve public safety and recognize the valuable service of these men and women who risk their lives every day to keep us all safe. Let's hope they wield their power wisely.

STEP M SETTLEMENT MEANS BACK PAY FOR MEMBERS

Retroactive Step M status for 103 members

We have good news for members who were improperly denied **Step** M pay by the Department.

Your Union has achieved a settlement agreement that provides retroactive Step M status to **103 members** including Classification Counselors, Psychologists, and Mental Health Counselors.

This will result in a back pay award for these members.

The affected members were improperly blocked from attaining Step M after the Union negotiated a salary range increase for them.

The Department maintained that the change to a higher salary range made all of those members ineligible for Step M, including the ones who had achieved Step L when the change was made.

Your Union filed a grievance over the issue and ultimately moved the case to arbitration when it became clear that the Department was unwilling to resolve the case in the early stages of the grievance process.

Prior to the arbitration hearing, Local 117's General Counsel Spencer Thal and Director of Corrections & Law Enforcement Michelle Woodrow were able to successfully settle the case in the Union's favor.

"I've been here 30 years and haven't received a step increase in a long time," said Robert Martin, a Classification Counselor at WCCW. "It's nice to see that people who have been working here for so long will finally get their increase. They deserve it."
