Getting to know your Union



TEAMSTERS LOCAL 117 - OUR MISSION: We build unity and power for all working people to improve lives and lift up our communities. This is our Union.

With 17,000 members across the Pacific Northwest. Teamsters Local 117 is the third largest Teamsters Local in the United States. The strength of our union is our membership. The active participation of Local 117 members is instrumental in helping to achieve industry-leading contracts that ensure that your wages, benefits, and working conditions are protected.

Looking ahead: We envision a world where workers are united for social, political, and economic justice and our collective voice is loud.

Our Commitment as Teamsters

As a member in good standing, I proudly pledge to faithfully uphold the constitution and bylaws of the International Brotherhood of Teamsters and Local 117. I will faithfully perform any duties entrusted to me to the best of my ability. I will conduct myself at all times in a manner as not to bring reproach upon my union.

As a member in good standing, I shall be entitled to all of the rights and privileges of membership!

Your Rights of Membership

You have the right at any time to elect to be a member of the union or a non-member of the union. As a member, you will have the following rights:

- 1. The right to attend and participate in union meetings, including contract demands meetings and ratification meetings, and the right to vote on any union business including contract ratifications;
- The right to run for union office, the right to nominate individuals for union office, and the right to vote for union officers;
- The right to receive an honorable withdrawal card upon the termination of employment, which allows members to work in other Teamstersrepresented positions without paying an initiation fee;
- The right to participate in certain union benefits, including the Teamsters Life With Dues insurance policy which provides a \$5,000 life insurance benefit, a \$5,000 accidental death and dismemberment policy, and a \$2,000 spousal life insurance benefit.

Most importantly, the union's strength and ability to represent your interests depends upon you exercising your right, as guaranteed by federal law, to join the union and engage in collective activities with your fellow workers.

Please be advised that nonmember status constitutes a full waiver of the rights and benefits of Local 117 membership. More specifically, this means that you would not be allowed to vote on contract modifications or new contracts; would be ineligible to hold union office or participate in union elections and all other rights, privileges, and benefits established for and provided to active Local 117 members by the Teamsters international constitution, Local 117 bylaws, or established by the Local Union.

Your Dues Dollars at Work

Teamsters support their union in many ways. One way is by paying dues, in the same way many Americans give to their places of worship or other organizations in their community. These dues enable your union to have the resources to stand up for good jobs and benefits, decent working conditions, and a better future for our familes.

Prompt payments of your dues are important: Failure to make payments can result in the suspension of your membership. Failure to make full payment of your dues as required may generate a late notice or a late fee. These notices will be sent to your last address on file.

If you allow your dues to fall three months behind, we are required by the Local 117 bylaws to suspend your membership. If your membership is suspended you will be required to reinstate your membership and may be required to pay a reinstatement fee plus all dues and fees you owe.

Dues payable to Local 117 are not deductible as charitable contributions for federal tax purposes. However, dues may qualify as a deductible work expense, subject to regulations under the Internal Revenue Code.

Change of Address or Employment Status

It is your responsibility to notify Local 117 your mailing address changes. You can do so online at: Teamsters117.org/your_info.

If you leave your job for any reason, please call the union at 206-441-4860 to request a withdrawal card. Your withdrawal card will allow you to rejoin Local 117 at a later date without paying an initiation fee.
