Hall wants to run for IBT President, but he's been missing in action and hasn't attracted much support. He was completely silent when the IBT gave UPS concessions and then imposed the contract over a No vote by the members. That's not leadership.

Taylor imposed two-tier concessions on UPS package car drivers, settled for \$13 an hour starting pay for part-timers, and called UPS feeder drivers lazy. But he hiked his own salary by \$41,000. Should officials who bargain concessions and impose them after members vote No get that kind of raise?

Ernie Soehl
