TENNESSEE RIGHT TO LIFE 2017 ART CONTEST FAQ

Who is eligible to participate?

Students in grades 9 through 12 are eligible to participate. Simply submit the registration form by **April 7, 2017**.

When will the contest be held?

Tuesday, **April 11, 2017** in conjunction with the TRL Oratory Contest. Arrangements should be made with Tennessee Right to Life to deliver the artwork *before* the contest or it may be delivered directly to Calvary Baptist Church, 3200 Kingston Pike by no later than 3:30 on the day of the contest.

Must I be present at the contest to win?

Participants and their families are encouraged to attend the contest to listen to the Oratory Contest participants and for the awards presentation, but attendance is not required to participate or place in the Art Contest.

What are the rules for the art projects?

1. Contestants are to create an original work of art illustrating an aspect of one of the life issues: abortion, infanticide, stem cell research, or euthanasia. Any medium may be used including sculpture and photography, but **NOTHING computer generated**. No graphic depiction of violence is permitted.
2. Entries may range in size between 12"X18" and 24"X36" canvas or poster board.
3. Submit registration form by April 7, 2017.
4. You may title your work, preferably apart from the work itself.

What are the prizes?

The Knox County Chapter of Tennessee Right to Life will award \$100, \$50, and \$25, for the top three winners. In addition to the cash prizes, a special gift will be given to all participants.
