Regulation of Abortion Facilities (SB1280 - Hensley / HB1368 - Lynn) Tennessee State Senate, April 15, 2015

The Tennessee Senate passed SB1222 by a vote of 28 - 4. This bill will require abortion facilities to be inspected and licensed by the Tennessee Department of Health in order to hold abortion providers accountable.
