Dear Mr. Combs:

This letter responds to your above-referenced Public Records Act Request made by letter to the Monterey County Sheriff's Office dated July 27, 2016, and received on August 1, 2016. Your request asks for:

Request:

1. Any and all records that constitute, relate to, or refer to your and the Monterey County Sheriff's Office's current policies and practices for LTC applications and licenses currently in effect, including both published and internal records.
2. Any and all records that constitute, relate to, or refer to any local carry license or identification instrument, the date that any local carry license or identification instrument was placed into use or service by you and/or the Monterey County Sheriff's Office, and the legal authority(s) under which such local license or identification instrument was or is issued.
3. Any and all records that constitute, relate, or refer to tables, lists, figures, statistics, or reports on approved LTC license holders, denied license applications, approved amended licenses, denied license amendments, or revoked licenses generated and/or maintained by you, any former sheriff or acting sheriff, and/or the Monterey County Sheriff's Office. (NOTE: This request item does not seek the generation or production of new records.)
4. For the period of January 1, 2014 to July 27, 2016: A copy of every LTC issued by you, any former sheriff or acting sheriff, and/or the Monterey County Sheriff's

Office, whether an initial license or a renewed license, of every type. Under this request item, we seek a copy of the active licensees' California DOJ standard license form as well as any local Monterey County Sheriff's Office license form, identification instrument, and attachment/addendum, if any.

5. For the period of January 1, 2014 to July 27, 2016: A copy of every LTC application (initial or renewal) that was approved by you, any former sheriff or acting sheriff, and/or the Monterey County Sheriff's Office. This request includes, but is not limited to, any and all records that constitute, relate to, or refer to California DOJ standard form BOF 4012, local forms, supplemental writings (e.g. "good cause" statements articulated outside of Section 7 of form BOF 4012, letters of reference / recommendation, and all related or like records), and any other writing submitted with or subsequent to the submission of an LTC application.

Response:

We have identified records responsive to this request. Copies of these records are provided on the enclosed CD.

Please be advised that every effort has been made to provide all disclosable records which might fall within the scope of your inquiry. As such, we believe our reply is quite thorough. However, if you have knowledge of a specific document which has not been provided in response to your inquiry, please notify us and we will be happy to provide the document(s) to you unless, of course, it is exempt from disclosure pursuant to Government Code Section 6254.

If you wish to dispute any of the determinations contained in this response to your request(s), please advise us of your legal argument. If you would also please provide us with a cite or legal authority which supports your argument we will be willing to reconsider our opinion.
