The Giving Spirit's mission is to help the homeless in the greater Los Angeles area one individual at a time by assembling backpacks and duffel bags (called "survival kits") filled with essential items for survival on the streets and distributing the kits directly to recipients.

The Giving Spirit held two public outreach events in May and December of 2019 to finalize assembly and distribution of survival kits. TGS also held 14 pre-outreach curated events to prepare kit items for the two public outreach events. All events included live education programs on homelessness and related issues, including videos produced by TGS. TGS volunteers created and distributed 7240 survival kits throughout the streets of Los Angeles. Volunteers package food, toiletries, clothing, blankets and other supplies into backpacks and duffel bags and then hand-deliver them to homeless people living on the streets and at local agencies. Donations and in-kind item and special skill donations received by the organization were used to support the expenses of these events throughout the year, including educational programs.
