- 1) Housing: We need to take steps to end the hoarding of the City's housing assets by the <1% and limit the influence of the real estate/tech cabal in City Hall. Legislating a pied-a-terre and vacancy tax, and true disclosure in real estate transactions will be 1st on the agenda. I'd also like to attempt hyperlocal introduction of public housing using the model introduced by SFCHA.

 2) Environment: Protecting our clean water resources is a priority for me as is the protection of San Franciscans from environmental toxins. I'll legislate our right to clean drinking water by requiring that contaminated groundwater (I have the test results via Records Request from PUC) is decontaminated prior to introduction into the potable supply. The solution to pollution is not dilution. I'll also legislate the immediate removal of toxic waste tires from our city's playfields and playgrounds starting with those over the groundwater supply. Requiring cleanups of HP Shipyards and Treasure Island are necessary to put an end to those massive ecofrauds and to protect our communities.
- 3) Privatization: Protecting our streets, sidewalks, parks, and public properties as held in the public trust not as playgrounds for profiteers is a must.

I am running a serious, values-oriented, grassroots campaign and am well-known and regarded in my neighborhood. I am firmly committed to Grassroots Democracy, Social Justice and Equal Opportunity, Ecological Wisdom, Non-Violence, Decentralization, Community-Based Economics and Economic Justice, Feminism and Gender Equality, Respect for Diversity, Personal and Global Responsibility, and Future Focus and Sustainability.

I teach Ecoliteracy to PreK, TK, and elementary-age SFUSD students. I have a wife and 10 year old son. I've lived in SF for over 20 years, most of my adult life, and have scraped and scrapped and saved to do so. I love SF (still). I value the relationships I have with my family, students, colleagues, and the work I do which is organized around ecological principles that matter cycles, energy flows, and everything is interconnected (and that there is no free lunch). I will maintain those relationships and organizational principles throughout the campaign--and, with different dynamics, if elected.

I have consistently stood up against gross injustices in our City as an "act of injustice anywhere is a threat to justice everywhere". Opposing #ToxicTurf and prosecuting the action for a Citizens Ballot Measure Initiative, #RecallEdLee at the request of #Frisco5, and putting a Referendum on the streets to repeal the Density Bonus Plan for #SanFranciscoLand were not a hat-trick but were simply the right things to do. Running for Supervisor, independent of the political apparat, is another which I determined to do well before the calculated and carefully orchestrated "retirement" of the current apparatchik.

Early on in the campaign, I reached out to other independent candidates, Adam Kim and Dan Kappler, during the signatures-in-lieu period and coordinated an RCV strategy with them as they share my values (Dan's signatures were rejected by Elections and he missed the cut-off date to qualify). Having attended candidate trainings and supporting the work of FairVote locally, I know what needs to be done to run an effective, DIY, low-cost campaign. I will see it through and work to ensure the accuracy of the final vote tally.

I am not a career politician. I will bring a fresh, mechanic's approach to the BOS and attempt to deconstruct the relationships between elite special interests and governance by exposing them and operating with transparency and openness. I feel that we are at a critical point in our City's history, a moment we should seize and empower each other to embody the forces for positive change we wish to see in our City and in the world. I'd like to do just that, and leave the door open for the next to do the same.
