What are the top three issues you will work on, and how will you implement solutions in a timely manner? (1250 character limit)

1) Student Achievement for Latino, African-American and API Students

-Expanding African American Achievement Leadership Initiative to create Office of Equity
-Concentrate on Strong Start (prioritizing TK-3rd Grade education) to make sure every child has the supports they need to reach their marks by 3rd grade. Prioritizing early identification of learning difficulties, reclassification of English Language learners, and family support.

-Expanding community schools model. Wrap around support services for families on site so our children can be in a place to learn when they enter the classroom

2) Livable Wage for Educators and Paraprofessionals

-Redistribution of funds so higher percentage of budget is allocated to school sites to increase educator and paraprofessional salaries.

-Introduce 1% tax on corporations earning net profit of \$100 million or more to go directly to funding teacher salaries so they have wages comparable to police officers and firefighters (\$85k)

3) Healthy Delicious School Lunches

-Buildout kitchens on school sites so we can create locally sourced, nutritious and delicious meals that our kids will eat.

San Francisco suffers a continued affordability and housing crisis. Please explain how you think this crisis should be addressed (in general), then list actionable concrete steps you would take, if elected, to move toward those solutions. Include an explanation of whose interests you will prioritize.

We are in a huge undersupply of housing for moderate or middle income families. I believe that every new development in San Francisco should contain at list 30% housing for moderate and low-income families so we can keep the wealth of diversity in our City. San Francisco is unaffordable for many families, firefighters, teachers, police officers, and they are forced to move outside the City to find space. I would love to see a requirement that any new housing development in the City must include 30% for middle to low-income families. Programs must also be set up to help low-income families qualify, be credit ready, and assist in the entire process of navigating the BMR system. I have advocated and received funds through my time with the Latino Parity and Equity Coalition for outreach to Latino families re: BMR units. With the proper guidance and support, this community helped increase its percentage in BMR units. Also, I am very proud that we have strong renter protections here in San Francisco. Rent control should be expanded, especially in historically Black and Brown communities and more resources given to staff so they can find and prosecute predatory landlords. Personally, with SFUSD more housing needs to be developed for our teachers, so we can end the constant flux of staff. I am a big proponent of using available land to create Teacher housing and to prioritize that housing go to staff working in our high need schools. I am also in favor of expanding City programs like Home Match that partner with homeowners who have extra space/rooms with those who work or are in school. We have to get creative with our solutions and work fast to address this crisis, or else it could irreversibly change our city.
